# Obstetrical Anesthesia Research

Frank Maziarski and Catherine Luria After seven years of research, WANA President Dan Simonson's article concerning the incidence of obstetrical anesthesia complications in Washington State Hospitals has been published in the January/ February 2007 issue of Nursing Research. The study analyzes 12 years of hospital discharge data, from 1993-2004. Washington routinely collects this data as part of the Comprehensive Hospital Abstract and Reporting System (CHARS). Hospitals were characterized as falling into one of four different staffing patterns: CRNA-only; Anesthesiologists-only; Collaborative (where anesthesiologists and CRNAs worked together on individual anesthetics); and Combined (anesthesiologists worked at the same hospital, but not together on the same anesthetics) of these only those hospitals with CRNA-only and Anesthesiologist-only were included in the study. This method provided the easiest way to determine the effects of individual provider staffing because the other two types varied widely in the amount of involvement of the providers. The results demonstrated that CRNAonly hospitals had fewer obstetrical complications than anesthesiologists-only hospitals. However, it is important in any research of this type to adjust for the results based on risk factors that might affect the outcomes. For example, if anesthesiologist-only hospitals were taking care of sicker patients, one might expect that they would have a greater number of anesthetic complications. After applying statistical techniques to account for such differences, the results changed to show that there was no difference between the two types of hospitals. Simonson states, that "in times of decreasing reimbursement for medical care, it becomes important to determine the best use of our resources. Hospitals, CRNAs and Anesthesiologists should all be pleased to have reassurance that CRNAs working without anesthe siologist supervision can safely take care of the anesthetic requirements of the obstetrical patients". # **Dental Commission and Anesthesia**

At their October meeting the Washington Dental commission accepted, without any modifications, the dental Anesthesia Committees recommendations of proposed changes to the Washington Administrative Code (WAC 246-817-180). Their proposal is to delete the portion of the regulatory language that requires the dentist to meet special training and education criteria when using the services of a CRNA. The rational behind this pro-

posed change is that CRNAs should not be held to a different standard than other anesthesia providers.

# **Podiatry Regulations**

# **Early Injury Detection**

Early detection and prevention of conditions such as tendonitis and carpal tunnel syndrome may be closer than we thought. Scientists at Temple University are involved in a new study which found that the human immune system produces biomarkers, which are certain types of chemicals, when the body starts to injure itself with repetitive motions.

At this point in time, repetitive motion injuries are diagnosed based on physical observations and concerns voiced by patients. The goal of scientists is to "find a way to detect the problem before it starts". This will al-

low researchers and healthcare providers to evaluate the effectiveness of current treatment of repetitive motion injuries and help prevent the need for costly surgeries. These findings may also save employees and employers from lost revenue due to injured employees.

The study included 22 participants who suffered from repetitive motion injuries. Each participant was given a physical examination which rated the severity of their individual injuries. After each examination, a blood test was given to test for biomarkers. The blood tests showed the presence of several types of biomarkers which indicated to the scientists the existence of the patient's underlying problem. The amount of biomarkers present determined the severity of the injury. Scientists have also found these biomarkers in rats in previous studies.

# Listening

In this article, I will continue illustrations of the Art of Listening, a concept that is difficult to balance with the schedule.

I noticed Lisa, age 16, when she arrived in the office. She was dressed in perfectly matching clothes, matching backpack, and not a hair out of place in her puttogether look. When she had called for her appointment, her main complaint was labial and vaginal irritation. It was a busy day; my ARNP world seemed to be a sea of complaints, tests, and charts.

I thought of the history form. Usually, the medical assistant would take the initial history so that my time could be focused on the exam, the tests, and the prescription. But, Lisa was a teenager...and listening, really listening, with teens is important.

I decided to bring Lisa back to the room myself. I made a conscious decision to just sit with Lisa for a few minutes and get the whole picture of her life right now. No forms. No writing. Not yet.

I asked Lisa, "How are things going for you, Lisa? What brings you in today? How are things at home?"

As she talked, Lisa began to cry. I listened and added, "I want you to know that what you say here is confidential." "Who is important to you these days, Lisa? Are you sexually active with guys, girls, both, or neither?" Lisa told me she had been dating Jeff, but then she met Joan and they had been hanging out a lot. She and Joan had become a couple. Her parents found out that she was gay, and kicked her out of the house. She had been

staying with one friend or another. She was still in school, and she had not told anyone what happened. And now, with this soreness, she was really scared.

While Lisa talked, I gave her my total attention. I kept eye contact and I did not look at the forms on the desk. I slowly laced in the open ended questions as I listened. This was the application of Kris Swanson's Caring Theory, the concept of *knowing*. Knowing in Lisa's case was about seeing all of who Lisa was right now. Adolescent identity development is fluid. Steele (2006) found that 100% of patients will disclose their sexual identity if the provider asks in a sensitive and open way.

The concept of *being there* is about presence and compassion. In Lisa's case, presence was given by eye contact, attending, and extending empathy. "Wow, Lisa, that sounds like a tough situation."

Swanson's concept of *maintaining belief* would be illustrated by demonstrating faith in the ability of the patient to negotiate difficult life transitions or events. "Lisa, there is a lot going on in your life. And look at you. You are put-together as usual, and I can see that strong confident 'you' that I remember ever since you were four. I remember you would sit in my lap and take my otoscope and suggest that you could check my ears."

"So, what are your thoughts about all this?" "Who can you count on for help right now?" "What are you scared of?" "What do you want from this visit?"

After really listening, it is much easier to move on to the exam and tests (the *doing for* in Swanson's Caring Theory). Next, we could begin finding the right resources for Lisa. (Swanson's enabling concept). Most importantly, because she was directly asked about her sexual orientation (1), Lisa was able to 'come out' with one person, her ARNP (3). Health care environments often place a patient in the situation of *continual* coming out. We had avoided heterosexual assumptions (2) and we had established trust, openness, and respect (4).
