Medicaid Requires Tamper Resistant Prescriptions by Bob Smithing

Effective October 1, 2007 tamper resistant prescriptions will be required for any prescription written for a patient covered by Medicaid. This is being required nationally by an amendment to Section 1903b(i) of the Social Security Act (42 USC193b(i), paragraph (23) which now states "(1) Payment shall not be made for amounts expended for medical assistance for covered outpatient drugs (as defined in section 1927(k)(2)) for which the prescription was executed in written (and non-electronic) form unless the prescription was executed on tamper- resistant pad (paper)".

It is interesting to note that there is no requirement for prescribers to write tamper-resistant prescriptions but rather that pharmacists will not be paid for prescriptions if they are not tamper-resistant. According to MSNBC.com this provision was tucked into a spending bill for Iraq.

On August 17, 2007, The Department of Health & Human Resources, Centers for Medicaid & Medicaid Services sent a letter to all of the State Medicaid Directors. (http://www.cms.hhs.gov/SMDL/downloads/SMD081707. pdf) This is an excerpt from that letter.

The purpose of this letter is to offer guidance to State Medicaid agencies on section 7002(b) of the U.S. Troop Readiness, Veteran's Care, Katrina Recovery, and Iraq Accountability appropriations Act of 2007. regarding the use of tamper-resistant prescription pads, which was signed into law on May 25, 2007...

To be considered tamper resistant on October 1, 2007, a prescription must contain at least one of the following three characteristics:

1) one or more industry-recognized features designed to prevent unauthorized copying of a completed or blank prescription form;

2) one or more industry-recognized features designed to prevent the erasure or modification of information written on the prescription by the prescriber;

3) one or more industry-recognized features designed to prevent the use of counterfeit prescription forms.

No later than October 1, 2008, to be considered tamper resistant, a prescription pad must contain all of the foregoing three characteristics. Failure of a State to enforce the tamperresistant pad requirement of section 7002(b) may result in the loss of Federal financial participation.

According to the above letter the payment limitation does not apply to e-prescriptions transmitted to the pharmacy, prescriptions faxed to the pharmacy, or prescriptions communicated to the pharmacy by telephone by a prescriber. Also exempt are prescriptions provided in skilled nursing facilities and certain other settings, if the facility provides the prescriptions as part of the facility charge. Prescriptions paid for by a managed care entity are exempt. Refills of written prescriptions presented at a pharmacy before October 1, 2007 are exempt as well. Drugs provided in the office incident to a provider visit, for which the office will bill Medicaid, are also exempted.

Seeking Board of Directors Members for ARNPs United of WA State!!

Last October at the Primary Care conference, ARNPs United of WA State (AUWS) created a transitional board of directors to help revive the organization. Prior to October, there were membership renewal issues, bylaws untouched for a decade, a tired website, and a newsletter in search of members' contributions. Since October of 2006, 13 volunteer Board members, an Executive Director and a paid staff member have been working tirelessly to fix these problems and help the organization move forward. We have written a new set of bylaws, updated our monthly newsletter and our website (check both out at www.auws.org), doubled our membership by reaching out to all ARNPs across the state, and overall, brought the organization from worn out to downright great!

Now we need your help. This November, at the Primary Care conference, we will hold an election (our first in a very long time) for a new board of directors. All BOD positions are open; the transitional members have the option of running, as does every AUWS member. The bylaws call for 5 to 9 members on the BOD, with 4 of them serving as Board officers - President, President-Elect, Treasurer, and Secretary. The Chair of the Legislative Committee is automatically on the BOD as well (Legislative Committee members meet separately.) Board officers will be determined by the BOD after the election – so far it's been a case of who is willing and able to do what. The term of service is 3 years. The time involved is approximately 5-10 hours per month, as we have monthly to quarterly board meetings (which can be attended via conference call) and subcommittee work based on your area of interest. Our subcommittees include the ARNP CARE newsletter, the website, membership, and public relations.

Elections for the Board of Directors will be held this coming November at the Primary Care conference. I highly encourage everyone to consider running for a position on the Board. In fact, I have enjoyed the experience so much, I plan to put my name on the ballot. The time commitment is approximately 5-10 hours per month and a 3 year term (and more if you would like!) Meetings are held monthly to quarterly. There is the ability to teleconference so you don't have to be physically present at the meetings. We hope to have board members representing various areas of the state and specialties. This is a great way to be involved and give back to our profession.
