Your Help is Needed Attend Nurse Legislative Day

As many of you have read in prior issues, our #1 legislative priority for 2008 is the removal of the 72 hour dispensing limitation on Schedules II-IV drugs. If you are reading about this for the first time, it is important to know that this is a restriction related to *dispensing*, not prescribing. Dispensing is the physical act of handing someone medications. Typically, samples or pain medications are involved. We have compiled a small list of scheduled drugs which are now being distributed as samples and packaged in more than 72 hours' worth of dosing. These include Ambien, Lunesta, and Provigil. Here is a brief historical review: A bill passed in 2000 allowing ARNPs to have prescriptive authority for Schedule II-IV drugs also placed a 72 hour limitation on dispensing these drugs. Proponents of this restriction argued it would reduce criminal activity, such as theft from clinics owned by ARNPs, diversion, and black market sales. Our legislative committee is conducting research to determine if there is evidence that this has been a problem specific to ARNPs. We have been meeting with legislators to garner their support and plan to introduce a bill in both the House and Senate before the legislative session begins on January 14th, 2008.

We cannot do this alone! We need your help! Nurse Legislative Day is Monday, February 4th, 2008. In recent years, ARNPs attending Nurse Legislative Day represented us well by visiting nearly 40% of all the legislators in Olympia. We have successfully passed legislation expanding ARNP scope of practice almost every year for the past 5 years. This year we plan to do it again! Register for the event at www.wsna.org and plan to attend the ARNP breakout session at 11:15am, where novices and experts alike will be briefed about the 72 hour bill and other ARNP issues. This will prepare you for an afternoon of meetings with your legislators, which we urge you to schedule in January. Less Paperwork with Labor and Industries? Interested in Becoming an L&I Provider?

The Department of Labor and Industries (L&I) has designed a new form to reduce paperwork for health care

providers. The Insurer Activity Prescription Form (APF) integrates medical information on workers' conditions, restrictions, and prognoses, with the overall goal of improving communication between the provider, employees, insurers, and injured workers. Effective November 1st, 2007, ARNPs can be paid for submitting the APF to communicate work status, work-related physical restrictions, verification of time-loss (if appropriate), and treatment plans. It will replace two Self-insured forms (the Supplemental Medical Report and the Employer Requested Physician's Estimate of Physical Capacities) and four State Fund forms (the Time-Loss Notification (TLN), Supplemental Medical Report (SMR), Physicians Final Report (PFR), and the Doctor's Estimate of Physical Capacities (DEPC) and PhysicalCapacities Evaluation (PCE)).

A Brief Review of EMDR

As more and more soldiers return from combat in Iraq, health providers will be faced with a large group of patients who have experienced life threatening stress on a daily basis for months at a time. EMDR (eye movement desensitization and reprocessing) introduced by Francine Shapiro in 1989 is one of the therapy approaches useful for this situation.

This review is based on an article from the Journal of EMDR Practice and Research, volume 1, #2, 2007 EMDR, Adaptive Information Processing and Case Conceptualization which I found to be a very well organized and clear presentation of the therapy technique. I also acknowledge Maxwell Knauss, PhD for his helpful input.

EMDR is an integrative, client-centered psychotherapy approach that emphasizes the brain's information processing system and memories of disturbing experiences as the basis of those pathologies not caused by organic deficit or insult. EMDR's wide range of therapeutic applications is grounded in the adaptive information processing (AIP) model that guides its clinical practice. It can be used to treat both major life-threatening trauma as well as the traumas generated by life events.

The adaptive information processing (AIP) model proposes that in order to make sense of incoming stimuli, new experiences are assimilated into existing memory networks. In a healthy individual, as new experiences are processed they are "metabolized" or "digested" and what is useful is learned, stored with appropriate emotions, and is available to guide the person in the future. Pathology results when unprocessed experiences are stored in their own neural network, isolated, unable to link up with anything more adaptive. Subsequent new information, positive experiences and affects are unable to link into the network where the unprocessed traumatic material is isolated. Adaptive learning cannot take place because of this dysfunctional storage.

When a current event stimulates the memory networks, it may cause unprocessed stored negative emotions, physical sensations and perspectives to emerge, although this may not be in the patient's conscious awareness, essentially re-traumatizing the patient. The goal of EMDR is to access the dysfunctionally stored experience and to stimulate the patient's innate processing system allowing a resolution of the experience. The event and what has been learned can be verbalized but the inappropriate negative affects and physical sensations can no longer be felt. This processing is at the heart of every EMDR treatment.

DDAVP Spray No Longer Indicated for Primary Nocturnal Enuresis

According to the FDA's MedWatch manufacturers have been requested to update the prescribing information for desmopressin to include important new safety information about severe hyponatremia and seizures. Certain patients, including children treated with the intranasal formulation of the drug for primary nocturnal enuresis (PNE), are at risk for developing severe hyponatremia that can result in seizures and death. As such, desmopressin intranasal formulations are no longer indicated for the treatment of primary nocturnal enuresis and should not be used in hyponatremic patients or patients with a history of hyponatremia. PNE treatment with desmopressin tablets should be interrupted during acute illnesses that may lead to fluid and/or electrolyte imbalance. All desmopressin formulations should be used cautiously in patients at risk for water intoxication with hyponatremia. Additional information is available
