Suboxone & ARNPs

In the article titled Passage of our "72 Hour" Bill! We said that "We now have full prescriptive authority in WA State with no exceptions". The Federal Government has approved only DOs or MDs who have taken a special certified course and who work with addicted patients to prescribe Suboxone. ARNPs can not prescribe Suboxone (buprenorphine and naltrexone.)

"Refuse and Refer" Update AUWS and Washington Chapter of ACNM Sign on *In Amicus* against Refuse and Refer By Ann Darlington

ARNPs United of WA State and the Western WA Chapter of the American College of Nurse-Midwives have signed on "in amicus" to a medical brief arguing for patient access to prescribed medications, and against "Refuse and Refer" options for pharmacies and pharmacists. We join multiple other medical, public health, human rights, and medical ethics organizations, as well as professionals and professors of law. Recall that in November '07, U.S. District Court Judge Ronald B. Leighton issued a preliminary injunction putting on hold rules enacted in April '07 by the Washington State Board of Pharmacy (BOP). The rules (WAC 246-869-010 and WAC 246-863-095) were adopted to protect patients' access to lawful prescription medications without discrimination or delay. Under these rules, if a pharmacist objects to dispensing a medication for personal, moral, or religious reasons, the pharmacy can accommodate the objecting pharmacist. But the pharmacy must also have on site another pharmacist available to fill the prescription in a timely manner. The overreaching goal of the BOP is to ensure that a pharmacy or pharmacist's objections do not impede timely access to medications, which could have serious and unpredictable effects on people's health and safety. Health and safety protection of its citizens are two major functions and responsibilities of government.

Two pharmacists and the legal representatives of Ralph's Thriftway Pharmacy in Olympia challenged the BOP rules.(Ralph's is owned by the Storman family.)They claimed that filling prescriptions with which they morally disagree impinges on their constitutional rights. Such prescriptions include but are not limited to "Plan B", a commercial brand of emergency contraception. Leighton, a conservative judge in Tacoma, agreed with and laid down an injunction against enforcement of the rules until the issue could go to trial in a higher federal court. [See ARNP Care article July '07]. Challenged in February '08, Judge Leighton again refused to remove his injunction and thereby permitted it to stand pending appeal. This means that the BOP rules forbidding "Refuse and Refer" are not enforceable while we await a higher federal court appeal, and thereafter only if the appeal is won. Thus, the current effort to eventually enforce the BOP rules is focused on the trial at the 9th Circuit Court of Appeals in San Francisco, slated for October 2008.

As the medical amicus brief states, we "are troubled by the district court's holding, which allows pharmacies to refuse to dispense medications necessary for patients' health ... " A sampling of the list of organizations who are "friends" and "joiners" of the medical brief demonstrates the widespread concern for access to care underlying this issue: the American (and WA State) Public Health Associations, the American Academy of HIV Medicine, the Lifelong AIDS Alliance, Equal Rights Washington, Northwest Health Law Advocates, the WA State Coalition of Mental Health Professionals, the WA State Nurses' Association, the Women's Bioethics Project, and the Program for Appropriate Technology in Health. ("PATH" is the international organization that in 1997 initiated the successful pilot program in our state for direct access to emergency contraception from a pharmacist). Several well-known individuals have also joined the medical amicus, including Susan F. Wood, PhD, the nationally respected biologist and women's health policy specialist. Further, many prominent current and past legislators have signed on in a separate legislators' amicus, including Senators Margarita Prentice, Jeanne Kohl-Welles, Adam Kline and Rosa Franklin, Representatives Eileen Cody and Mary Lou Dickerson, and former Senators Phil Talmadge and Pat Thibaudeau. And finally, several faith-based organizations and leaders have signed on in a *religious* amicus (see the Religious Coalition for Reproductive Choice website article at

www.rcrc.org/news/brief_Stormans_0308.cfm).

The organizations spearheading the complex legal effort to return to enforcing the BOP rules include Planned Parenthood of WA State, the American Civil Liberties Union, and the Northwest Women's Law Center. Opposing them is the Alliance Defense Fund, a national right wing think tank based in Arizona, and the primary funding source for those claiming the right to "Refuse and Refer" in our state. Peruse their website (http://www.alliancedefensefund.org) and you will find that the ADF feels "blessed to provide some organizations a substantial portion of their funding for various cases and projects, and for some a significant portion of their total litigation budget... in the legal struggles for religious freedom, the sanctity of life, and to preserve marriage and the traditional family". Although most obstetric experts, including the American College of Obstetricians and Gynecologists, state that emergency contraception is not an abortifacient, the ADF claims it is an "abortion-producing drug" and therefore pharmacists should have the right to refuse to participate in "the taking of human life".

The defendants in the "Refuse and Refer" case in the 9th Circuit Court are Mary Selecky of the WA Department of Health and Judith Billings.(Billings is the past Superintendent of Public Instruction who became infected with HIV from infertility treatments in the early 80s, and is currently board chair of the National Association of People with AIDS.) The plaintiffs are Stormans Incorporated, the owners of Ralph's Thriftway. The medical amicus brief for the defendants focuses on protection of public health and access to care, and asks the court "to explain why the State's ability to enforce laws that prohibit pharmacies from refusing to deliver lawfully-prescribed drugs to patients in a timely manner jeopardizes patients' health, and interferes with physicians' legal and ethical obligations to protect their patients' health." They are particularly focused on the emergency element of some meds, whose efficacy (and therefore the patient's health) is compromised by delay, like drugs treating mental health, HIV, and emergency contraception.

The focus in this case is on "Plan B", but if the BOP rules were overturned, the option to Refuse and Refer would not be limited to any one drug or class of drugs. It would be left to the discretion of individual pharmacies and pharmacists to decide which prescriptions are acceptable to fill and dispense. That is why such a wide range of people and organizations, advocates for people with HIV, mental health, women's right to choose, and (above all) access to care, recognize the long-term underlying threat. Any prescription could one day be found objectionable. Any consumer could be turned away. Anyone's health could be seriously affected.
