# Spotlight on a BOD Member Catherine Luria

You may meet me on the bike trail, English Country dancing in Seattle, playing flute in the Gig Harbor orchestra or singing. These are some of the ways I take my own advice to have a varied and exciting life. However, one of the main joys of my life as an ARNP in family practice is helping my patients lead a more active, balanced and healthy lifestyle, no matter what challenges they are dealing with concerning their health.

My husband and I moved to Washington State in 1976, after the new nurse practitioner act had been passed allowing prescriptive authority but before the rules and regulations had been written. I had the exciting opportunity to be very active in helping prescriptive authority become reality. This also enabled me to meet many other nurse practitioners, especially from Seattle, and to feel part of Washington's wonderful community of NPs. I am proud to have been issued the first license to prescribe legend drugs in Washington.

When we first moved to Washington from above the Artic circle in Alaska, we opened a new satellite clinic in Port Orchard for a Tacoma based HMO. My husband is a family practice physician, and we had worked together during our two years in the US Public Health Service (1974-76) so we were a good team for this project. In Gallup, NM I was the nurse practitioner instructor for the physician assistant program, chosen because half the Native Americans in this primary care PA program were LPNs or RNs. The program wanted to incorporate concepts from nursing into the program, particularly for the group of students whose background was from lab or x-ray technology. I taught physical assessment and normal and pathophysiology in tandem, shar-

ing the load with 3 MDs. We desensitized our students to test taking fright by giving short tests every Friday using all the styles of questions found on national boards exams. (All the students passed their national boards!)

In Kotzebue, AK (42 miles above the Artic Circle) the medical staff was three MDs and one NP – me. In that setting I was doing inpatient care as well as outpatient care and delivered 15-20 babies. One exciting memory is delivering a baby the night the lights were out in the labor & delivery suite. Fortunately I had a real sharp RN working with me, and we were working by a battery operated spotlight, so that little baby slid out into a hushed and dimly lit room – a perfect birth for me to always remember. In Kotzebue I learned everything from doing spinal taps and hand dipping my own x-rays to ice fishing, doing daily medical call by short wave radio to ten remote villages, and to really appreciating the return of the sun after our 23 days of darkness. I really enjoyed my years in the USPHS.

My educational background includes a BS in chemistry and a MS in nursing from NY Medical College's Graduate School of Nursing in 1968. This was the only program of its type in the US in 1966 that required all students to have a BS or a BA in a field other than nursing as a prerequisite. All the nursing was concentrated in two years and one summer. In retrospect this program was preparing us for an expanded role in nursing.

Public health in Rochester, NY was my first area of employment in a very run-down inner city district. I was chosen in 1969 to move to a new inner city neighborhood health center to help define a NP role for PHNs at this developing clinic. What an exciting time! We created an intensive in-service program for ourselves. Barbara Bates, MD taught us physical diagnosis using the mimeographed version 1 of her future textbook. I had previously been trained as a psychiatric liaison nurse through the community mental health center serving our clinic, and then as part of our program we all studied family therapy at the CMHC. The role of the PHN (NP) was to be the generalist on the team who integrated family practice, (including obstetrics), and mental health for the patient, thus starting my longterm interest in combining family and psychiatric modalities. Subsequently I taught pediatric nursing in the outpatient department at the College of Nursing, University of Kentucky, which gave me a nice opportunity

to solidify my grasp of pediatrics by teaching another generation of nurses.

Why I'm a member? I care that NPs practice in an environment where we can utilize our skills and knowledge to the fullest, and where we can continue to develop innovative roles for NPs to help meet the many unmet health needs of the country. Likewise, I care that we be recognized as a legitimate voice on health care matters by legislators and the public, and that we receive adequate compensation for our work. I hope AUWS can help unite the NPs across Washington and be able to speak with a strong voice, especially in the legislature and as the public voice of NPs.

# Please Help Your Texas NP Counterparts

I am a family nurse practitioner in Victoria, Texas and am sending this brief survey on behalf of the Texas Coalition for Nurses in Advanced Practice (CNAP). Laws regarding advanced practice nursing (APN) prescriptive authority are very restrictive in Texas, and we are initiating efforts to attain independent practice. Physicians have expressed concern that if APNs have independent prescriptive authority, APNs will become owners of practices and will directly compete with physicians. In addition, we need your perspective on the advantages of independent practice for APNs.

Therefore, CNAP is gathering information from "independent" states, such as yours, regarding independent prescriptive authority. We would appreciate your responses to the following questions.

- ☐ In what state do you practice?
- ☐ Has independent prescriptive authority helped your ability to practice? How?
- ☐ Has independent prescriptive authority improved access to health care in your state? If so, are any statistics available to support this?
- How many (total number or percentage) APNs own their own practices (APN is not employed by a physician or a facility)?

# DOH Takes Steps to Speed Licensing and Cut Backlog

The Department of Health launched a new computer licensing system in February. As many of you know, there was a rise in the backlog during that startup. This has caused serious delays in processing licenses and renewals.

There is good news, during the past several weeks, the backlog has dropped from 18 days to about 10 days.

The Department expects processing to continue to speed up. Many factors have contributed to the improvement. Some of the most important are:

- ☐ Staff is learning the system.
- Additional hardware, memory and Internet capacity has improved system performance.
- ☐ Staff resources have been added.

The Department has also focused attention on the most urgent license renewals. This will help to avoid having licenses expire when the department has already received a renewal with the correct information and fee.

Those seeking renewals can help speed the process. Our automatic renewal system is working smoothly. If a customer submits the correct fee, provides required information and has no changes to a license, the Department can process the renewal in a day or two.

By contrast, manual renewals are currently taking about two weeks to process. Manual renewals have to be done when a customer wants to make changes, such as in an address, forgets to submit continuing education information or submits the incorrect fee. The Department hopes to see the two-week lag time reduced to less than a week very soon.

The Department is encouraging customers to submit address changes separately. This allows them to get a faster renewal. Customers can send changes in names or address to either their email box or fax machine. The email address is hpqa.csc@doh.wa.gov and the fax number is 360.236.4818.

The Department is working hard to get their new system running smoothly.
