The Doctor of Nursing Practice Degree

In 2004, the American Association of Colleges of Nursing (AACN) adopted a position that all advanced practice nursing education, should occur at the doctoral level by the year 2015. This practice focused education leads to the Doctor of Nursing Practice (DNP) degree. According to AACN, there are nearly 80 DNP programs accepting students and more than 140 additional nursing programs considering starting a DNP. The University of Washington DNP program started in January 2007 and is the only DNP program in the state. It has options for advanced practice nurses who complete a post-master's program and for nurses with BSN degrees who will become advanced practice nurses including nurse practitioners, clinical nurse specialists, nurse midwives, and community health practitioners. Several other universities in Washington, including Washington State University and Seattle University, are planning DNP programs that will begin over the next year or two. Many programs will continue to offer master's degrees along with the DNP.

Why Obtain a DNP?

The DNP will prepare advanced practice nurses with competencies in clinical care, practice inquiry, teaching, health policy, and leadership for practice in an increasingly complex health care environment. Factors that contribute to this increasing complexity include an aging population, an increase in chronic health problems across the lifespan, and health disparities. The AACN defines advanced practice broadly and includes direct care of individual patients, management of care for individuals and populations, administration of nursing and health care organizations, and the development of health policy.

The DNP program is designed to prepare nurses to integrate evidence-based research into practice and results in a capstone project, while the PhD program focuses on nursing science development, research methods, and conducting a research project and results in a dissertation or research papers. Both PhD and DNP programs set high standards and focus on advancing the nursing profession. A few of the benefits of a DNP program include knowledge to improve evidence-based nursing practice and patient care, stronger leadership skills for quality improvement and changing health systems, enhanced knowledge of health policy for increased participation as advocates for change, and the ability to use information systems and technology to advance nursing practice.

Some currently licensed advanced registered nurse practitioners (ARNPs) are concerned that the educational transition to the DNP will require them to obtain a DNP. Current Washington State nursing rules require a graduate degree for licensure as an ARNP. This means that both the master's and DNP degrees are accepted as meeting eligibility for licensure. Any post-BSN DNP student will be able to obtain a license as an ARNP since the DNP degree is a graduate degree. The Nursing Care Quality Assurance Commission is not considering any change to that requirement at this time. National certification is also required for licensure as an ARNP in Washington State. National certification

organizations currently require either a master's or DNP degree for an individual to be eligible to take the certifying examination. The DNP degree is not required by any certifying organization at this time.

When Is a Rash Not Just a Rash? When It's Measles

We've all seen the little kid zooming around the waiting room. What if that child had measles? How many of your patients and staff would be exposed? How much time would you spend notifying patients about that exposure, and how many of your staff would be furloughed from work for weeks because they were exposed, but not immune, to measles? The numbers add up quickly. If you want to avoid that scenario, read on. The recent measles outbreak in Grant County illustrates the wideranging effects of one measles case. The Grant County index case, who developed measles symptoms about 2 weeks after attending a conference in King County, transmitted the infection to other family members. One of the subsequent cases went on a school field trip while contagious, exposing hundreds of school kids and some health care workers.

Where did some of these children go when they became ill with a fever and rash? Right—a health care facility like yours. And if you are unprepared, you too could have someone with measles expose you, your coworkers, and your patients—in waiting rooms, exam rooms, and treatment rooms.

So here's how you can be prepared.

Be sure that your staff are immune to measles. Persons are considered immune if they have one of the following:

- □ documentation of health care provider diagnosed measles
- ☐ laboratory evidence of immunity to measles (rubeola)
- ☐ written documentation (including dates) of 2 doses of live measles vaccine. Self-reported doses or parental history of vaccination alone are not acceptable.

Although most people born before 1957 are immune to measles, not all are. During 1985–1992, 27% of the measles cases in health care workers were in persons born before 1957 (*MMWR*, 46(RR18), p. 10).

Therefore, you should consider MMR vaccination for unvaccinated workers born before 1957 who do not have a history of measles disease or lab evidence of immunity.

Measles spreads through respiratory droplets and airborne transmission. Review airborne precautions for

your facility with your staff, including reception staff, so they understand their important role in infection control

Screen patients calling for appointments, to identify those with febrile rash illnesses.

Arrange "special handling" for patients who may have measles: direct them to a different entrance (avoiding the waiting room), schedule them as the last appointment of the day, evaluate them in a vehicle, or have them wear a mask before entering the building.

Post visual alerts (in appropriate languages) at your front entrance instructing patients and the persons who accompany them to cover their coughs and to inform health care personnel of symptoms of a respiratory infection when they first register for care.

Screen arriving patients for rash illnesses. Rapidly isolate them from other patients as noted above. Only staff immune to measles should enter the room of a suspected measles patient.

Provide tissues and alcohol-based hand rub for patients.

Minimize number of staff who have contact with patient.

Wear personal protective equipment while examining the patient.

Remember that measles transmission can occur in closed rooms (exam room, bathroom) for up to 2 hours after a person with measles has been in the room.

Measles is not the only disease that could infect patients and staff in your facility. When you implement the steps above, you'll be well on your way to limiting the spread of other respiratory illnesses such as influenza, pertussis, and SARS. You'll be glad you did.

Persons who work in medical facilities are 13 times more likely to be exposed to measles than the general-population. During 1990–1991, 668 of the 1,788measles cases reportedly acquired in medical settings occurred among health care workers. Five hundred sixty-one (84%) of those 668 were unvaccinated, 187 (28%) were hospitalized, and 3 died (MMWR 46 (RR-18), p. 10). And in 15 of the 75 measles outbreaks reported during 1993–1996, transmission occurred in a medical facility (www.cdc.gov/vaccines/pubs/pinkbook/downloads/meas.pdf, p. 141).
