Home Health Care Planning Improvement Act

The Home Health Care Planning Improvement Act of 2008, H.R. 6826, is a bill introduced into U.S. Congress that would change Medicare law to grant Nurse Practitioners, Physician Assistants, Clinical Nurse Specialists, and Certified Nurse Midwives the ability to order and certify home health care services. Currently, Medicare regulation allows only physicians to initiate or certify home health orders. This bill was sponsored by Representative Allyson Schwartz (D-PA) and needs more cosponsors. Please write your state representative in Congress to ask for their support and co-sponsor this important bill. Important Information to Ensure Continuity of Payment

The Department of Social and Health Services is implementing a new Medicaid payment system (ProviderOne). To ensure continued payment while this system is being implemented the key step is the registration activity. Many providers use clearinghouses to process payments and will need the clearinghouse new ProviderOne ID to complete their own registration.

Many clearinghouses have begun setting up security so they can complete the registration process. To determine if your clearinghouse is making progress on registration visit

http://maa.dshs.wa.gov/dshshipaa to review a list of clearinghouses that have been active with DSHS in the past year, their new ProviderOne ID number, and a status of their registration activity. If your clearinghouse is not on this list it is vital to "check in" with them to stress the importance of registration to continue payments.

Providers who bill on their own behalf will have an opportunity to complete their registration soon.

ARNP Reimbursement Rate Inequality 'The Same Pay For The Same Service'

In 2002 a Washington State advanced registered nurse practitioner (ARNP) filed a complaint with the Office of the Insurance Commissioner (OIC) after identifying that the Regence Blue Shield reimbursement policy for ARNPs might be violating the state's Health Care Services Contract Act (RCW 48.44.290). Regence arbitrarily set ARNP reimbursement at 95% of the physician rate for performing the same service. An initial ruling from the OIC found Regence in violation of state law. Regence appealed the decision in 2003. The OIC sided with Regence and refused to require a change to its reimbursement policy.

The Washington State Nurses Association (WSNA) challenged the OIC decision in 2004. The OIC ruled that the law did not address contracts between providers and insurers and avoided ruling on the issue of whether a reimbursement rate that was an arbitrary percentage of the physician reimbursement rate was legal.

In 2005 WSNA brought the issue to the King County Superior Court but lost. The court ruled that the term "health care service contract" used in the law referred to contracts between the health plan and the insured individual and did not extend to the health care provider. The ruling suggested that the law was not violated unless there was complete denial of coverage and that the law did not have legal force in addressing reimbursement parity for ARNPs because it did not affect the agreement between the health plan and the provider. This loophole in the current law has allowed Regence to reimburse ARNPs at a rate lower than that of physicians for the same service. In addition, the Washington State Department of Labor and Industries reimburses ARNPs at 90% of the physician fee schedule.

The current law negatively impacts access to care for many people because ARNPs may be less willing to accept patients with health plans that offer reduced rates of reimbursement. There are over 4,600 ARNPs licensed in Washington State. ARNPs include certified nurse midwives who provide obstetric care; nurse anesthetists who provide anesthesia care and nurse practitioners and psychiatric clinical nurse specialists who provide both primary and specialty care. ARNPs work in urban and rural areas and care for underserved and vulnerable populations. According to a University of Washington study, ARNPs provide 12% of primary care in rural areas of the state.

When a health plan reduces reimbursement to an ARNP the patient is billed the same amount and receives no reduction in premium or co-pay. The reduced ARNP reimbursement benefits the health plan while reducing access to care for patients.

The proposed legislation would require health plans and state agencies to provide the same rate of reimbursement for ARNPs as physicians receive when the same service is provided. This would be based on the use of national, standardized billing codes.

Rationale Payment equal to that of a physician for a service provided by an ARNP is an access to care issue and an issue of equality and nondiscrimination. When an ARNP makes a decision about which patients to accept into the practice based on the rate of reimbursement this can reduce access to care. Health plans that reimburse at 100% of the physician rate provide a more stable financial base for ARNP practice and access to care than health plans that arbitrarily reduce reimbursement to ARNPs. Given the shortage of primary care providers in Washington, this law will increase access to care for many people while addressing a loophole in the current law that unfairly discriminates against ARNPs.
