### Medical Home/Multipayer Group

In June, the WA state Health Care Authority and DSHS initiated a meeting between health care plans, purchasers, and providers to determine how to improve health care (more prevention/screening, optimal management of chronic health conditions, gateways to care, reducing hospital admissions & ER visits, etc) in a cost effective manner. The group has since eliminated the Medical Home moniker since so many are uncomfortable using the term. The end goal of the group process is changing patient outcomes, and reconsidering provider payment is a large part of this process. Governor Gregoire had the opportunity to discuss the group's work with President Obama during a June meeting with him and indicated that Washington State may be one of the models for developing a coordinated health care system.

Aetna, GHC, Cigna, Community Health Plan, Group Health, Regence, United Healthcare, and Premera indicated support for moving forward in this process. The Washington State Medical Association and the Washington Association of Family Practices were represented. Alaska Air, Boeing, and the the Association of WA Businesses (a small business organization) were also represented. During the initial meeting health care plans were given 4 minutes to discuss their concerns, and provider and purchaser representatives were given 2 minutes. During ARNPs United's time, we discussed access, international perspectives on an increased nursing role, the NP's preventive and care coordination core, and inclusiveness. Afterwards several MD group and health care plan representatives indicated that they "tend to forget" NPs, and appreciated our representation. Common concerns among group representatives were developing a common metric across all health plans, having an administratable system, moving beyond fee for service (many spoke of capitation), engaging the consumer, developing a system that works for practices of all sizes, and pilot projects already in place across the country.

August's meeting will be dedicated to reviewing current data and pilot projects already in place to cull lessons learned and to outline the process for the group's work. In September, there will be a Summit meeting using concrete scenarios to discuss issues involved. It will use an interactive, electronic response system to engage the group. ARNPs United's purpose will be to

keep patient access and inclusivity at the forefront as we move forward.

#### Seeking Board of Directors Members for ARNPs United of WA State

#### L&I Changes for Psychiatric ARNP Rules

The Department of Labor & Industries has adopted changes to the Washington Administrative Code. The amended WACs will do the following:

- Allow psychiatric ARNPs to treat injured workers WAC 296-23-241, and
- ☐ Clarify that concurrent care providers can prescribe medication while providing care to injured workers WAC 296-20-071 and WAC 296-21-270

The new rule was effective July 31, 2009. We are encouraging psychiatric ARNPs to submit applications now to become workers' compensation providers so you can start treating injured workers on July 31, 2009. You can do this electronically by going to www.lni.wa.gov and clicking on "managing claims for injured workers" and then "becoming an L&I provider."

# HHS Announces \$13.4 Million in Financial Assistance to Support Nurses

HHS Deputy Secretary Bill Corr on August 12 announced the release of \$13.4 million for loan repayments to nurses who agree to practice in facilities with critical shortages and for schools of nursing to provide loans to students who will become nurse faculty. The funds were made available by the American Recovery and Reinvestment Act (ARRA).

"The need for more nurses is great. Over the next decade, nurse retirements and an aging U.S. population, among other factors, will create the need for hundreds of thousands of new nurses," Deputy Secretary Corr said. "The awards from these two HRSA programs will help us meet projected demand for their services."

The awards come from two programs administered by HHS' Health Resources and Services Administration (HRSA): the Nurse Education Loan Repayment Program and the Nurse Faculty Loan Program.

Funding announced today under the Nurse Education Loan Repayment Program (NELRP) totals \$8.1 million. Those funds, awarded competitively, will help 100 registered nurses pay their nursing education debts. The program repays 60 percent of the loan balance of registered nurses in exchange for two years of service at facilities with a critical shortage of nurses. http://newsroom.hrsa.gov/releases/2009/nelrprecips.htm Participants may be eligible to work a third year and receive additional repayment assistance.

Funds announced today under the Nurse Faculty Loan Program (NFLP) total \$5.3 million. Those funds go to schools of nursing to support the training of 500 masters and doctoral nursing students who plan to become nurse faculty after completing their education. Following graduation, loan recipients may cancel up to 85 percent of the loan principal and interest in exchange for four years of service as a full-time nursing faculty at a school of nursing. Approximately 50,000 individuals interested in going to nursing school are turned away due to insufficient capacity at schools of nursing. The two main factors limiting the ability to train more nurses are a faculty shortage and insufficient clinical training sites.
