H1N1 Vaccine

This fall, the federal government is planning to provide H1N1 (swine flu) vaccine to states at no cost. Vaccination is strictly voluntary. Some vaccine supplies (needles, syringes, sharps containers, and alcohol swabs) will also be provided at no cost.

The Washington State Department of Health and local health partners invite interested licensed health care providers and facilities (including hospitals, clinics, pharmacists, and community vaccinators) to preregister to receive this new vaccine.

Becoming an H1N1 vaccine provider is a two-step process. First, pre-register by completing the online application (www.doh.wa.gov/swineflu/h1n1reg.htm). Second, sign the H1N1 Provider Agreement with the final terms. We'll send the agreement to you before vaccine is sent to your clinic site.

There is no cost to pre-register and no obligation to order vaccine. Local health agencies will make final decisions about which providers receive H1N1 vaccine in their communities. Pre-registered providers will receive periodic e-mail updates. H1N1 information is also available on our Web site: www.doh.wa.gov/swineflu.

Update on Prescription Refusal

The saga continues as the local version of the prescription refusal issue works its way through our legal system. Washington is not alone in dealing with this issue; similar fights are happening in the legislative arenas of Idaho, Montana and New York. Many have called it "Refuse and Refer," reflecting the claim that it is appropriate for a pharmacy or a pharmacist to refuse to fill prescriptions to which they object on religious or moral grounds, and to refer clients elsewhere. It has also been called "Prescription Refusal," since some have argued that it is their right to altogether refuse to fill an objectionable prescription (like Plan B) with no obligation to send a client elsewhere.

Our local story's name has evolved along with its history. It began when two pharmacists and one pharmacy challenged the 2007 Washington Board of Pharmacy's rules requiring that legally prescribed medications be filled. The legal title in Washington state's case is "Storman's vs. Selecky," that is, the owner of Ralph's Thriftway Pharmacy in Olympia (Storman) against the Secretary of the WA State Department of Health (Mary Selecky). Local legal folks now call it the "Pharmacy Refusal" case, because in its current phase, the Storman's case focuses specifically on the right of the pharmacy to refuse to fill objectionable prescriptions.

Some basic background: In the spring of 2007, the WA State Board of Pharmacy (BOP) adopted two sets of rules governing "Pharmacies' Responsibilities" and "Pharmacist's Professional Responsibilities" (WAC 246-869-010 and WAC 246-863-095) to protect patients' access to lawful prescription medications without discrimination or delay. Under these pharmacy rules, if a pharmacist objects to dispensing a medication for personal, moral, or religious reasons, the pharmacy can accommodate the objecting pharmacist. But the pharmacy must also ensure that the prescription is filled in a reasonably timely manner. A summary of the local legal battle: So far in WA state, it's all been about an injunction - no trial has yet taken place. In October 2007, Storman's (represented by the ultra-conservative Alliance Defense Fund, which is headquartered in Arizona) won its bid in the western WA US District Court (Judge Ronald B. Leighton presiding) for an injunction against the WA BOP rules for all pharmacies and pharmacists in our state, thus putting legal restraints on the application and enforcement of the pharmacy rules. In May 2008, the US 9th Circuit Court of Appeals (in San Francisco) declined to stay (that is, remove) the injunction pending their full appeal of the case. That appeal was finally completed on July 8, 2009. The Circuit Court repealed the injunction, saying, "Because we conclude that the district court incorrectly applied a heightened level of scrutiny to a neutral law of general applicability, and because the injunction is overbroad, we vacate, reverse, and remand." In simpler terms: the Circuit Court found that the District Court erred in how it viewed the case and therefore ruled wrongly in allowing the injunction against the BOP rules. Storman's had argued that the Free Exercise Clause of the 14th Amendment to the US Constitution ("Congress shall make no law prohibiting the free exercise of religion") meant that because of their religious beliefs, they were singled out, and that the rules were specifically directed against religion and religious practices. The Circuit Court disagreed, stating that the rules were neutral and had general applicability: "...the purpose of the new rules was not to eliminate religious objections to delivery of lawful medicines, but to eliminate all objections that do not ensure patient health, safety, and access to medication." Storman's has already asked the 9th Circuit Court of Appeals to re-hear their case, arguing that there should have been a full panel of 9 judges ruling on their case, rather than the panel of three who reviewed it.

Professor Will Huhn recently wrote about both the national and WA state issues in the Akron Law Café blog (see

www.ohioverticals.com/blogs/akron_law_cafe/2009/07/st ormans). He explained it this way: "Laws that are directed at religion are subject to strict scrutiny and are presumed to be unconstitutional. In such cases the government bears a heavy burden of proving that the law is constitutional. In contrast, neutral laws of general application are unconstitutional under the Free Exercise Clause only if the law lacks a rational basis—that is only if the law has no tendency to achieve any legitimate state purpose..." Referring to the Storman's case, he said, "The Court of Appeals remanded the case to the lower court so that it could determine whether the law in fact serves as a rational basis...[that is]...whether the plaintiffs challenging the law had 'negated every conceivable basis supporting the new rules.' In light of the standard established by the Court of Appeals' ruling, it is likely that on remand the District Court will uphold the constitutionality of the regulation." We'll see about that.

So what's next? If the Circuit Court is willing to re-hear Storman's case, that rehearing would happen sometime this winter. If as expected, they decline the rehearing request, Storman's would probably petition the US Supreme Court to review the Circuit Court's decision to lift the injunction. Of course one never knows, but it is likely the Supreme Court would decline to review the Circuit Court's findings, which would end the injunction phase of all this. Only then can the case finally go to trial, which would be back in Judge Leighton's District Court. The sole issue to be resolved there would be whether or not the BOP had a rational reason to pass the rules in the first place. Once that decision is rendered, the side that loses would likely appeal that finding, so the case would yet again go back to the 9th Circuit Court of Appeals. And after that? If the Circuit Court's decision were appealed again, the next step would be the US Supreme Court. Justice is convoluted!

As a sidebar and on a personal note, I wish to recognize that not all nurse practitioners agree that the BOP rules are appropriate; they believe that some version of "Refuse and Refer" should be the right of pharmacies and pharmacists. These NPs fear similar rules restraining their own practice choices. However, the rules do allow for certain exceptions and accommodations - for example, when there is simply no call for a given medication in a pharmacy's market area (e.g., Plan B doesn't fit in a pharmacy catering to a geriatric population), or the patient has no means or intention of paying for the med, or another pharmacist can do Plan B counseling over the phone. This is all very complicated, but let us remember that the primary issue is access to care, including patients' access to all legally prescribed meds, controversial or not. We at ARNPs United of WA State will continue to listen to those who worry about the BOP rules. We will take to heart the need to remain vigilant in maintaining balance between rules and rights, and to retain prescriptive authority as a part of access to care. My belief is that just as the BOP rules allow pharmacists to defer to an in-house or on-call colleague to fill a legal prescription, so can we continue to find a middle ground that allows us to practice within our scopes and our comfort zones as nurse practitioners.

Mom & Baby Mobile Health Centers Have Become Primary Care Providers Along the Gulf Coast

Four years after the hurricanes of 2005, four March of Dimes Mom & Baby Mobile Health Centers® serve as the primary health care providers for thousands of pregnant women, teenagers and children living along the Gulf Coast.

Launched as an emergency response to the devastation inflicted upon New Orleans and the region's hospitals and health care facilities, these mobile prenatal health centers have taken the place of regular health care provider for these areas. Although all of the hospitals in Jefferson Parish have reopened, four out of nine still remain closed in Orleans Parish and none have reopened in St. Bernard Parish.

They have provided more than 7,800 patient visits since they began operating in 2007. The centers travel throughout New Orleans and its surrounding suburbs. They make regular stops at community centers, churches, schools and even Kmarts in Biloxi, MS.

Some of the services provided by the mobile health centers include ultrasounds, prenatal visits, pregnancy testing, preconception counseling, CenteringPregnancy (a group prenatal care program), referrals to remaining hospitals in the area for high risk women who require specialized care, and postpartum checkups.

"Many of our patients are Spanish-speaking, and because we are bi-lingual we can offer these women access to quality health care," says Rosa Bustamante-Forest, RN, MPH, MN, program director for the Mom & Baby Mobile Health Center[®] in New Orleans. "We're seeing repeat patients from last year who are pregnant again, which speaks volumes to the quality of care we offer."

The Mom & Baby Mobile Health Centers were funded through the March of Dimes Hurricane Assistance Fund, including a \$3 million gift from the People of Qatar.

Inside, the Mom & Baby Mobile Health Centers look like a regular healthcare provider's office, with private exam areas, waiting areas and nurses' station. They are equipped with fetal monitors, ultrasounds and other equipment, and a backup generator. The handicap accessible centers have bilingual staff, including an obstetrician, nurse practitioner or midwife, a nurse, lab technician and an outreach worker. The vehicles have a fixed schedule at consistent locations so services will be dependable and expected.
