## Inaccuracies in the AMA Scope of Practice Monograph on Nurse Practitioners

The following paragraph is on page 6 of the AMA monograph on nurse practitioners and purports to summarize research that my colleague Marie-Annette Brown, PhD, ARNP, FAAN, and I conducted on transition of NPs to a new scope of practice.

NP advocacy organizations continue to lobby for immediate scope-of-practice expansions and development of DNP programs, even while some APN advocates warn that the profession is moving too fast. Take, for example, a conclusion drawn by nurse researchers who explored how NPs in Washington State adapted to new regulations allowing them in 2001 to prescribe Schedule II drugs under joint practice agreements with physicians, and in 2005 to prescribe those same drugs independently. By 2006, these researchers determined, 42 percent of NPs in the state had not applied for U.S. Drug Enforcement Administration endorsement to prescribe these drugs. In fact, the researchers reported that some of these NPs indicated they did not want the responsibility of having to deal with potentially drug abusing patients. Instead, many of these NPs stated they "wanted additional education about controlled substances to feel more competent with prescribing these medications." 12 As a result, one researcher concluded that "NPs need preparation for a new scope of practice long before legislation actually passes."13

There are many inaccuracies in this paragraph.

- There is no documentation that any APN advocate warns the profession is moving too fast.
- The Washington law allowed ARNPs to prescribe Schedule II-IV drugs for the first time, a much broader scope of practice change than just adding Schedule II drugs.
- It was by 2005, four years after the law passed, not 2006, that 40%, not 42% of ARNPs had not applied for Schedule II-IV prescriptive authority. The implementation of the law was in August of 2001, more than a year after the law passed.
- The sentence about NPs not wanting the responsibility of having to deal with potentially drug abusing patients infers that this was the reason 40% had not obtained Schedule II-IV prescriptive authority. First, the term 'potentially drug abusing patients' is

- not accurate as our research always referred to patients perceived to have drug-seeking behaviors, which is different. Second, NPs with and without Schedule II-IV authority both expressed concern about working with patients perceived to have concern about drug seeking behaviors.
- The use of the word instead in the next sentence is inaccurate. The NPs who wanted additional education about controlled substances were not the ones who expressed concern about patients perceived to have drug-seeking behaviors. Rather, nurse practitioners who had created a practice that excluded Scheduled II-IV drugs when it was not legal to prescribe them identified the need for more education. Further, this data was collected in 2004, less than 2 years after implementation of the law.
- The article that is cited was co-authored by Dr. Brown and I yet the last sentence in the paragraph states that one researcher made a conclusion. The statement that NPs need preparation for a new scope of practice was not connected to NPs who wanted more education. The statement was made in the context of assuring that NPs understand the effect of legislative changes at the individual level, which is often not clear when rules are necessary to implement the law.

The number of inaccuracies and misrepresentations in this one paragraph reflects the attempts of the AMA to discredit and diminish nurse practitioners and the valuable contributions they make to health care.

## Louise Kaplan, PhD, MN, ARNP to be Inducted into the WSNA Hall of Fame

The Washington State Nurses Association's (WSNA) recently announced that Louise Kaplan, PhD, MN, ARNP will receive the WSNA's highest recognition honor, induction into the WSNA Hall of Fame, at an event to be held on March 18, 2010. Louise will receive the honor for her many significant contributions to advancing autonomous advanced nursing practice as well as her many other significant achievements benefiting the entire nursing profession.

WSNA established the biennial WSNA Hall of Fame awards in 1996 to recognize outstanding registered nurses in Washington state, living or deceased, who have made significant lifetime accomplishments to the nursing profession and WSNA. To be honored with this award, inductees must have demonstrated excellence in the areas of patient care, leadership, education, public service, nurse advocacy, heroism, patient advocacy, or clinical practice, and for achievements that have affected the health and/or social history of Washington state and that have added value to nursing beyond the inductee's lifetime.

Louise will be recognized for her many leadership roles in WSNA, including president of her local district, WSNA vice president, board member, Chair of the WSNA-PAC, a two year term as WSNA president and nearly a decade as a member of the Legislative and Health Policy Council. Louise has been an invaluable resource using both her practice and her policy expertise to further WSNA's legislative agendas and in support of the profession's priority legislation. Her contributions include analyzing bills, testifying on behalf of WSNA, serving as the WSNA liaison to the state's Advanced Practice Coalition, and serving as WSNA's representative to select state advisory committees.

Several of Louise's contributions stand out as having a major life-long impact on professional nursing and WSNA. One example is that Louise was responsible for starting Nurse Legislative Day in the early 1980s. This statewide event has grown from 150 participants to more than 700 each year. Louise and her research colleague, Marie-Annette Brown, have spent the last eight years conducting important research on Washington's Advanced Registered Nurse Practitioners (ARNPs) with a special focus on prescribing controlled substances. In 2005, Louise testified on a bill on behalf of ARNPs by using their research to support elimination of a restrictive requirement for joint practice agreement with a physician to prescribe most federally controlled drugs. Thanks to her research and excellent testimony, the bill successfully passed the Legislature, providing ARNPs with fully autonomous practice. This intersection between research, service and practice exemplifies the

ideal way in which nursing research can make a difference to the profession.
