Depression in Older Adults: PHQ-9 for Screening

Depression affects over 121 million individuals globally. and is the leading cause of disability worldwide. As the fourth leading cause of disease burden, depression is also responsible for over 850,000 suicides a year (World Health Organization [WHO], 2010). In the United States, depression is a leading cause of disability in individuals' age 15 years and over (United States Preventive Services Task Force [USPSTF], 2009). In individuals 65 years old and over, the prevalence of clinically significant depression is 15%, with women being more affected at 17.8% (Federal Interagency Forum, 2006). Despite its prevalence, depression in older adults remains widely unrecognized and under-diagnosed. Some of the reasons providers may have difficulty recognizing depression in older adults are: patients may minimize or deny symptoms of depression, symptoms may be masked by comorbid chronic medical or mental conditions, clinicians may perceive the depressive symptoms to be a normal part of aging or a cultural attribute, or symptoms may present as other disease conditions e.g. pseudodementia. Additionally, the presence of somatic complaints further complicates the diagnosis of depression (Barnes, Veith, & Raskind, 1981). To decrease medical morbidity, the USPSTS recommends routine screening for depression in older adults. This should be done in primary care settings where diagnosis, treatment and follow-up are available (USPSTF, 2009).

A literature review of seven screening instruments was conducted. The instruments reviewed were: the Geriatric Depression Scale Short Form (GDS-SF), Patient Health Questionnaire 9 (PHQ-9), Patient Health Questionnaire 2 (PHQ-2), 10-Item Center for Epidemiologic Studies Depression Scale (CESD-10), 30-Item Inventory

of Depressive Symptomatology-Self Report (IDS-SR), 16-Item Quick Inventory of Depressive Symptomatology-Self Report (QIDS-SR 16), and World Mental Health Composite International Diagnostic Interview (CIDI). Of these instruments, the PHQ-9 was found to be the most appropriate screening instrument for screening depression in older adults.

Composed of nine questions, the PHQ-9 is derived from the Diagnostic and Statistical Manual of Mental Disorders -IV (DSM-IV; American Psychiatric Association, 2000). Advantages of using the PHQ-9 include: a high sensitivity and specificity of 77% and 94% respectively. the ability to detect various levels of depression severity, sensitivity to change over time, allowing providers to assess for improving or worsening depression; brevity, with only nine questions. Most importantly, the PHQ-9 contains the nine criteria required to make a diagnosis of depression (Wittckampf, Naeije, Schene, Huyser, & van Weert, 2007). As such, in addition to being a screening instrument, the PHQ-9 can also be used as a diagnostic tool in addition to the provider's assessment. The PHQ-9 is available in over 20 different languages.

In assessing depression in older adults, it is imperative for providers to distinguish screening from diagnosing. In addition to using screening instruments to screen for depression, providers need to further assess individuals in order to reach a diagnosis. Some factors to consider while performing further assessment of the individual include: prior functional and emotional characteristics, underlying medical or psychiatric conditions, cognitive impairments, cultural or ethnic identity, level of formal education and psychosocial factors e.g. recent losses (Roman & Callen, 2008). The combination of the scores from the PHQ-9 and the provider assessment provides a comprehensive diagnostic work-up for the diagnosis of depression in older adults.

Pain Management Rules Writing Workshop

The legislature passed ESHB 2876 during the 2010 legislative session. This bill requires five Department of Health boards and commissions to develop pain management standards in rule. The Medical Quality Assurance Commission (MQAC), Board of Osteopathic Medicine and Surgery (BOMS), Nursing Care Quality Assurance Commission (NCQAC), Dental Quality Assurance Commission (DQAC), and the Podiatric Medical Board (PMB) must adopt rules by June 30, 2011. In addition, MQAC, BOMS, and PMB must repeal existing pain management rules by June 30, 2011.

These five boards and commissions will use a joint collaborative process and selected representatives to participate in a workgroup. The first workgroup meeting will occur:

Washington Nurses Go Paperless

Some of you may have noticed that you did not receive your blue paper copy of your nursing license this year. **No need to panic!** Starting April 1, 2010, The Nursing Care Quality Assurance Commission has begun a new paperless system. Reasons for the system include decreasing the chances of fraudulent licenses; reduces the amount of paper = Going Green; most employers verify current licensure using Provider Credential Search anyway; employers who call for verification are referred

to Provider Credential Search; the savings in postage, paper, and envelopes is being redirected toward activities that protect the public.

You will continue to receive a notice of renewal 8-10 weeks prior to your birthday. Return the renewal card and payment as soon as possible. Check on line to confirm that your license was renewed – the process takes about 2 weeks.
