The Metabolic Domino

Chronic diseases are among the most common and costly medical problems; they are also among the most preventable diseases (Wilcox, 2004). Today, most Americans live long enough to acquire a chronic disease. To an ever greater extent, today's major health care problems are the result of chronic and acute conditions related to individual behavior (Strong, Mathers, Leeder, & Beaglehole, 2005). Seven of ten deaths in the United States are caused by chronic disease (Geberding, 2004). Most of these diseases have underlying risk factors that are modifiable. A significant proportion of diabetes and cardiovascular disease can be attributed to obesity, secondary to inactive lifestyles and unhealthy diets (Epping-Jordan, Galea, Tokuitonga, & Beaglehole, 2006). While mortality from some conditions is decreasing, morbidity from most chronic diseases continues to increase (Wilcox, 2004).

Itoh's (2006) interest in the interconnections of cardiovascular disease and diabetes was piqued by his studies involving the renin-angiotension system, precursors of the metabolic syndrome, and the role of inflammation in the vascular system. To make sense of his observations he proposed a concept known as the "metabolic domino," which connects genetic susceptibility, obesity, and chronic disease.

A new concept, the metabolic domino, captures the flow between genes, inactivity, and obesity as a domino-like cascading chain of events, resulting in end organ demise. The underpinnings of the metabolic domino are unique to each individual, with relative resistance determined by genetic predisposition, genetic strengths, and genetic vulnerabilities (Itoh, 2006). The interconnected relationships begin with a lifestyle change to inactivity, which triggers the falling of the first domino. The chain reaction is then set in motion, with obesity surfacing next. The demands on the body, imposed by obesity lead to insulin resistance, followed by postprandial hyperglycemia, hypertension, and hyperlipidemia. Once insulin secretion has toppled, diabetes begins to exact its erosive and systemic effects. With diabetes, the domino effect snowballs and with increasing momentum arteries become atherosclerotic, leading to ischemic heart disease and cerebrovascular attacks, and ultimately death (2006). In sum, the demands imposed on the body by obesity lead to chronic diseases and, eventually, to end-organ damage and death.

The metabolic domino concept captures the flow between genes, inactivity, and obesity, describing the course through chronic disease and end organ demise as a domino-like cascading chain of events (Itoh, 2006). When applied to patients, and used in patient teaching, it makes explicit the cost of obesity and inactivity. It is a useful concept in the teamwork between Nurse Practitioner and patient to right the disequilibrium of chronic disease.

Mental Health Parity Law

The third and final phase of Washington State's 2005 Mental Health Parity Law took effect July 1. Starting Thursday, any limits on the number of office visits or inpatient hospital days to treat mental disorders must be removed from all state-regulated health plans, unless the limits also apply to other health services. "For too long, people suffering with serious mental health conditions have had to piece together insurance coverage, if they had any at all," said Insurance Commissioner Mike Kreidler. "The final enactment of our mental health parity law is a victory for all consumers." The law was designed to phase in benefits over five years. In 2006, all health plans for employers with more than 50 employees that included medical and surgical services were required to also cover mental health services. In addition, the copays, co-insurance and prescription drug coverage limits had to be the same for mental health services. In 2008, these benefits extended to all regulated health plans, and if a plan had a maximum out-ofpocket limit, the limit had to apply to all services, including mental health. "As many individuals and families know, mental illness can be as devastating as any other health condition," said Kreidler. "It's only fair that people in need of mental health services have access to the same insurance coverage as other patients." Washington state's mental health parity law goes further than the Federal Mental Health Parity and Addiction Act of 2008. Under the federal law, health plans are not required to offer mental health services, but if they do, they must be on par with other health services. Also, the federal law only applies to employer health plans with more than 50 employees. Washington's new law first applied to just large employers but now applies to all regulated health plans.
