### Rural Opioid Addiction Management Cooperative

The problem of opioid-seeking patients in family practices is a source of enormous frustration for many providers. The lack of adequate alternative treatments for chronic pain and the many patients who have been exposed to opioid medications through licit and illicit channels makes clinical decision-making extremely challenging. The prescription of opioids skyrocketed starting around 1995. This trend was accelerated by the perception that it is the provider's job to deal with pain, as evidenced by the Joint Commission on Accreditation of Hospitals adding pain as a "vital sign".

The current situation is intolerable. The increase in opioid prescribing has led to non-medical use of opioids, especially among youth. Emergency department visits for opioid-related problems, and treatment admissions for prescription opioid addiction have also increased markedly. While selected patients can benefit from carefully prescribed opioids in conjunction with non-opioid medications and non-medication treatments for chronic pain, opioids are frequently misused, obtained without prescriptions or are diverted or sold. One consequence of increased illicit use is that of unintended overdose deaths. In Washington state deaths involving opioids rose from 23 in 1995 to 505 in 2008. Multiple drugs are involved in nearly all of these deaths. In 2008, prescription opioids were present in 60% of all unintended drug overdoses.

Unfortunately, once a person becomes addicted to opioids, it is very difficult if not impossible for them to withdraw without long-term treatment. The most com-

mon treatment for opioid addiction has been methadone, an inexpensive opioid that abolishes craving for other opioids while still allowing people to function normally. But methadone for treatment of addiction can only be dispensed in certified methadone centers, which require patients to make almost daily trips to receive their treatment. There are only 11 methadone centers in Washington State, and all of them are in urban areas. Rural providers until recently had very few tools to help their patients escape addiction.

In response to this epidemic, many governmental agencies have begun to change their policies governing opioid prescription. The Agency Medical Directors Group in our state – representing governmental agencies from Medicaid to Labor and Industries – have added restrictions to prescribing more than the equivalent of 120 mg of morphine per day to patients whom they insure. A new law was passed in the 2010 Washington State legislative session apply to this approach not only to recipients of government programs, but all patients.

But neither of these measures helps the unfortunate patient who wishes to quit using opioids, or his or her frustrated provider who can't get the patient into treatment. Recognizing this paradoxical dilemma, the federal government in 2000 passed a law – DATA 2000 – which allowed physicians to begin the outpatient use of buprenorphine (Suboxone or Subutex) to manage opioid addiction. Because buprenorphine is a partial agonist, it is much less likely to be lethal in cases of overdose. In addition, when compounded with naloxone (Suboxone), the risk of injection abuse is reduced. Buprenorphine greatly reduces opioid craving and blocks the effects of other opioids, making it a highly effective and well-tolerated medication for patients with opioid addiction.

Despite the potential advantages of the use of Suboxone as opioid replacement therapy for addicted patients, very few physicians have taken the 8-hour course that allows them to legally prescribe this medication for the treatment of addiction. This has been especially problematic in rural areas, where there are shortages of doctors but no shortages of patients addicted to opioids. As of 2010, only 32 rural doctors in Washington State had received the federal waiver that allows them to prescribe Suboxone.

Project ROAM is a new initiative by Washington State University and the University of Washington to assist rural physicians who wish to use this new modality to treat patients with opioid addiction.

During the coming year our team will present two free CME courses in Washington State that will teach rural physicians about the use of Suboxone for addiction, and also satisfy the federal requirement to receive legal permission to prescribe the medication. While ARNPs are not currently permitted to prescribe Suboxone they are welcome to attend the class especially if they are practicing with a physician who prescribes it. But just being able to prescribe the drug doesn't necessarily mean that it will be used. Many physicians are appropriately learn of opening the floodgates by acquiring this new capability. Project ROAM is committed to providing assistance to physicians who wish to use this medication, both by helping them master the clinical nuances of the protocols, and by helping them organize their practices so that this new clinical service is a benefit to their practice.

We will be launching this project in collaboration with Project ECHO, an innovative teleconferencing system that allows rural physicians (and their clinical support team) to participate in periodic clinical rounds with other physicians and with appropriate experts to discuss management of complex patients without leaving their offices.

A second resource will be the buprenorphine course instructors themselves.

Each rural physician who attends the course and is certified to prescribe buprenorphine will be paired with an expert mentor who is one of the faculty in the course. These experts will be available by phone or e-mail so rural physicians can receive timely consultations on management of individual patients, or any other matter related to the use of buprenorphine.

Third, Project ROAM will make available practice management consultation to help rural physicians train staff, devise forms, and shape clinical protocols for the efficient use of this medication in specific real world settings. The consultant will also assist the newly trained physicians with billing so that this service will be adequately reimbursed by third party payers.

The first course will take place in Seattle on Saturday, October 30<sup>th</sup>. Project ROAM will cover the cost of the course, and provide CME credits.
