## **Media Training Opportunity**

Family physicians, pharmacists, and naturopaths spend millions in Washington State every year promoting their profession. As such, they are frequently quoted in newspaper articles and on radio shows regarding current health care issues. In 2010, the American Academy of Nurse Practitioners made public relations for nurse practitioners a priority, bringing in Peter Van Sant, CBS News Correspondent, to interview members of the public in Washington State about their perspective on nurse practitioners. Unfortunately, few of those interviewed were even aware of what nurse practitioners are.

The board of ARNPs United believes the next step in effective interactions between NPs and legislators, health care leaders, and media representatives is broad PR training with a cadre of NPs from across the state prepared for radio and TV media opportunities. Public relations know-how allows individual NPs to develop an effective sound bite about their profession and to project confidence when opportunities arise to write articles to their local papers, or respond to local issues. As Peter Van Sant stated in June of this year, TV media are constantly looking for strong contacts in the health care sector to assist them in developing current topics.

# Propoxyphene Withdrawn Risk of Cardiac Toxicity

Sold as Darvon, Darvocet, and generics. The FDA notified healthcare professionals that Xanodyne Pharmaceuticals has agreed to withdraw propoxyphene, an opioid pain reliever used to treat mild to moderate pain, from the U.S. market at the request of the FDA, due to new data showing that the drug can cause serious toxicity to the heart, even when used at therapeutic doses. FDA concluded that the safety risks of propoxyphene outweigh its benefits for pain relief at recommended doses. FDA requested that the generic manufacturers of propoxyphene-containing products remove their products as well.

The FDA's recommendation is based on all available data including data from a new study that evaluated the effects that increasing doses of propoxyphene have on the heart. The results of the new study showed that when propoxyphene was taken at therapeutic doses, there were significant changes to the electrical activity of the heart: prolonged PR interval, widened QRS com-

plex and prolonged QT interval. These changes can increase the risk for serious abnormal heart rhythms.

The FDA recommends that healthcare professionals stop prescribing and dispensing propoxyphene-containing products to patients, contact patients currently taking propoxyphene-containing products and ask them to discontinue the drug, inform patients of the risks associated with propoxyphene, and discuss alternative pain management strategies. Patients were advised to dispose of unused propoxyphene in household trash by following the recommendations outlined in the Federal Drug Disposal Guidelines.

# 2010 STD Treatment Guidelines Update

As the holiday season approaches, we want to provide you with a quick update on the Sexually Transmitted Diseases Treatment Guidelines 2010. The Guidelines, which update the 2006 Guidelines, were published in the Centers for Disease Control and Prevention's (CDC) Morbidity and Mortality Weekly Report (MMWR) Recommendations and Reports on Friday, December 17, 2010. After the release, we encourage you to visit CDC's STD Treatment Guidelines 2010 webpage for additional information and updates. From there you will be able to order hard copies of the report as well as wall charts and pocket guides. A podcast featuring lead author, Dr. Kimberly Workowski, will be posted on Monday, December 20 for viewing. CDC is also developing iPhone and eBook applications of The Guidelines and will keep you updated on their progress and availability.

#### **Continuing Competency Requirement**

The Nursing Commission adopted continuing competency requirements. The rules go into effect January 1, 2011. The rules require completion of 531 hours of active practice and 45 hours of nursing continuing education by 2014.
