The Robert Wood Johnson foundation partnered with the Institute of Medicine (IOM) to release recommendations, formulated by non-nurses, with the goal of transforming the health care system. Two areas of focus are cost and quality of patient care and the policies that supported these foci. The first recommendation directed removal of scope of practice barriers, particularly for ARNPs. The key point acknowledged is that patients need access to ARNP care. ARNP care has a strong track record of high quality and increased access. The results of the IOM evidence-based research/study are profound, and represent a one in a lifetime blueprint for action.

In the action phase of the future of nursing, nurses will pair with American Associations of Retired Persons (AARP) to begin the implementation process. AARP is the second largest organization in Washington State. In this opportunity of a lifetime, we must determine critical area of expertise, practice our voice, and be strategic in our focus and timing, realizing that every nurse practitioner has a story to tell.

ARNPs United intends to represent you at the table. We thank our members. We appeal to those of you who are not yet members to consider membership in ARNPs United. Currently only 10% of ARNPs in Washington State are ARNPs United members and yet we support the other 90% of ARNPs. Loretta Ford Will Be Inducted Into National Women's Hall of Fame

Dr. Loretta Ford will be formally inducted into the very prestigious National Women's Hall of Fame on October 1, 2011. Dr. Ford was nominated for this honor by the American Academy of Nurse Practitioners (AANP) and the AANP Fellows. Inductees are selected every two years based on their lasting contributions to society. From a group of more than 200 nominations, a national panel of judges conducted a rigorous scoring process and selected 11 women for induction. The induction will take place in Seneca Falls, NY, the birthplace of the American Women's Rights Movement in 1848. "Each of these women have demonstrated fortitude, perseverance, intelligence and hope," said Christine Moulton, executive director of the National Women's Hall of Fame. Managing Chronic Pain White Paper Released

The Nurse Practitioner Healthcare Foundation (NPHC) Issues White Paper, "Managing Chronic Pain with Opioids: A Call for Change," to address critical topics. Pain is the most common reason to seek medical care, and is the leading cause of lost days of work. Nearly half of the U.S. population will seek care or treatment for persistent pain at some point in their lives. Nevertheless, untreated or under-treated pain remains a serious public health problem in our nation. With the "aging of America," the growing number of elderly who suffer from painful chronic conditions or require end-of-life care further highlights the urgent need for quality care

in pain management. Pain is costly to society, as it is a major cause of absenteeism and long-term disability. Even when patients with chronic pain continue to work, the cost to employers is over \$60 billion a year in lost productivity.

Chronic pain causes suffering that lowers quality of life, and creates social isolation and stigmatization. Although opioids help people function better, this gain is offset by the abuse, misuse and diversion of these medications, which costs the U.S. nearly \$1 billion/year. "Providing opioids to alleviate suffering for those with chronic pain — while keeping these medications out of the hands of persons who would misuse, abuse or divert them — is a national public health challenge," says NPHF President Phyllis Zimmer, MN, ARNP, FNP, FAAN.

Managing Chronic Pain with Opioids: A Call for Change, was written on behalf of NPHF by Paul Arnstein, PhD, FNP, FAAN and Barbara St. Marie, ANP, GNP, RN-BC. In the paper, the authors identify barriers to treatment, discuss the problem of abuse, misuse and diversion, present strategies for managing patients' opioid use, and highlight the need for standardized databases and terminology. They also stress that adequate patient and professional education is essential. The paper then presents recommendations for change that address the inter-related public health concerns of 1) inadequately treated chronic pain and 2) the misuse, abuse and/or diversion of prescription opioids.

Recommendations for managing chronic pain with opioids are presented in four areas, including:

- 1) Managing Patient's Opioid Use
 - Practice universal precautions
- Maintain awareness of the duty to alleviate pain and suffering while preventing Iatrogenic harm
- 2) Professional Educational Recommendations
 - Improve education for healthcare practitioners about chronic pain, pain management, opioid use, misuse, diversion and addiction
 - Provide education on chronic pain and on opioids for all members of the healthcare team
- 3) System-wide Recommendations
 - Increase reimbursement for health care professionals to accommodate the time needed to provide education, counseling, and nonpharmacologic interventions for chronic pain sufferers
 - Educate patients, family members, and communities about chronic pain and proper use of opioids
- 4) Regulatory and Policy Recommendations
 - · Facilitate referrals to pain specialists
 - Develop collaboration between law enforcement and the health professions to address misuse, abuse, and diversion of opioids
