## Proposed Bylaws Changes

The following are proposed changes to the AUWS Bylaws which will be voted on at our annual meeting Thursday 10/27/11 at 12:15pm at the Advanced Practice in Primary and Acute Care — Pacific Northwest 34th Annual National Conference.

Article II, Section 2: Add an additional membership category entitled "ARNP Membership" to include all individuals who are licensed as an ARNP in Washington State."

Article II, Section 3: Add the rights for the new ARNP Membership category, which are:

- a. Receive ARNP Care electronically.
- b. Participate as a voting member in meetings of the ARNP Assembly.
- c. Participate on ARNPs United of Washington State committees.

Article IV, Section 7.A.7 regarding terms for officers: Change the term for officers from 2 years to 1 year to reflect the current reality. Add a clarification that an officer can hold office for more than one term.

## DEA Clarification on CII Prescriptions

The Washington State Board of Pharmacy reaffirms its long held guidance and interpretation regarding changes to a CII prescription.

A pharmacist in consultation with the prescriber may change all elements of Schedule II prescriptions except the patient's name, the drug, or the prescriber's signature. The pharmacist shall note the consultation on the prescription. A pharmacist may add the patient's address or the prescriber's DEA registration number to the prescription without consulting the prescriber.

Question: What changes may a pharmacist make to a prescription written for a controlled substance in schedules III-V?

Answer: The pharmacist may add or change the dosage form, drug strength, drug quantity, directions for use, or issue date only after consultation with and agreement of the prescribing practitioner. A pharmacist may add or change the patient's address and may add the prescriber's DEA registration number to the prescription without consulting the prescriber. The pharmacist should note all consultations and corresponding changes on the prescription. Pharmacists and practitioners must comply with any state/local laws, regulations, or policies prohibiting any of these changes to controlled substance prescriptions.

### AUWS 501(c)(6) Notification

ARNPs United of Washington State (AUWS) is a 501(c)(6) organization. Member dues paid to such non-profit organizations are fully deductible on your tax re-

turn as a business deduction, except when the organization has lobbying expenses. Since AUWS engages in political and lobbying activities, it is the IRS's position that via your dues, you are indirectly paying for a lobbying activity.

IRC Section 6033 (e) and IRS Revenue Procedure 98-19, require a 501(c)(6) organization that “pays or incurs nondeductible lobbying expenditures to notify its members of a reasonable estimate of the portion of dues that are allocatable to those expenditures.” We have reasonably estimated the amount to be half of all dues paid. For example, if you paid \$150 in 2011 in member dues, half, or \$75, is your tax-deductible amount.

**All members are advised that 50 percent, or half, of dues paid to AUWS are nondeductible for income tax purposes.**
