### EDRS Coming to Skagit and San Juan Counties!

The Washington State Department of Health is releasing a new Electronic Death Registration System (EDRS) to Skagit and San Juan counties in early 2012. The EDRS is already being used in Benton, Franklin, Mason, Pierce, Thurston and Spokane counties, with close to 70% of all death records being filed fully electronically. EDRS will streamline the death registration process, improve the quality of the death data collected, and improve communication among those who file.

Everyone benefits with EDRS:

Providers will quickly complete a death record from any computer with web access and file it with a single click. This paperless system does not require extensive computer knowledge. It will streamline communication between funeral directors and providers and eliminate the need to fax or sign paper records. It will offer a fast, easy, more accurate way to file.

Families will get death certificates faster and will be able to do so from any local health jurisdiction across the state. EDRS will deliver better service to families because delays with paper processing will be reduced.

Funeral homes will save time and money by collecting providers' signatures electronically. They will view cases online and get death certificates faster.

The people of Washington will benefit by having immediate and accurate death data used to combat public health threats.

### AHRQ Stats on the Primary-Care Workforce

Despite serving as the "foundational element" of the U.S. healthcare system, the nation's primary-care network is experiencing "diminishing economic margins, and increasing workforce attrition compounded by diminishing recruitment of new physicians, nurses and physician assistants into primary care," according to the U.S. Agency for Healthcare Research and Quality.

AHRQ's Center for Primary Care, Prevention and Clinical Partnership will be issuing a "Facts and Stats Series" on primary-care topics designed to inform healthcare policy and decisionmakers on primary care's workforce, capacity and growth needs.

In 2008, Americans made nearly 956 million visits to office-based physicians, and 51.3% of those were to primary-care doctors—though slightly less than one third of the country's 624,000 doctors who spend the majority of their time in direct patient care are primary-care specialists, according to the first fact sheet in the series.

The second fact sheet cites CMS figures that put the 2010 nurse practitioner and physician assistant work-forces at 106,073 and 70,383. According to estimates by the Robert Graham Center, a non-partisan primary-care policy and analysis organization commissioned by AHRQ, the percentages of the nurse practitioner and physician assistant workforces practicing in primary care are 52% and 43.4%.

### The Number of Nurse Practitioners and Physician Assistants Practicing Primary Care in the United States

SUMMARY: In 2010, approximately 56,000 nurse practitioners and 30,000 physician assistants were practicing primary care in the United States, according to research commissioned by the Agency for Healthcare Research and Quality.


Nurse practitioners (NPs) and physician assistants (PAs) are health professions begun in the United States in the 1960s in response to shortages and uneven distribution of physicians. They play important roles in many health care fields and especially in primary care.

The Centers for Medicare and Medicaid Services maintains the National Provider Identifier (NPI) dataset, which listed approximately 106,000 practicing nurse practitioners and 70,000 practicing physician assistants in 2010. This estimate represents approximately 10,000 fewer practicing physician assistants than projected by the American Academy of Physician Assistants (AAPA) and approximately 10,000 more nurse practitioners than report having NP in their title in a 2008 national survey.<sup>1</sup>

To estimate the number of nurse practitioners and physician assistants who are practicing primary care, the Robert Graham Center used the NPI dataset to examine the practice partners of each nurse practitioner and physician assistant. Using a novel imputation method that assigned field of practice (primary care or a subspecialty care) to each NP and PA based on the specialty of the professionals they work with, the Center estimated that less than half of physician assistants (approximately 30,000) and slightly more than half of nurse practitioners (approximately 56,000) are practicing primary care in 2010.


## Primary Care Workforce Facts and Stats No. 1

### The Number of Practicing Primary Care Physicians in the United States

SUMMARY: In 2010, there were approximately 209,000 practicing primary care physicians in the U.S., according to research commissioned by the Agency for Healthcare Research and Quality.

Of the 624,434 physicians in the United States who spend the majority of their time in direct patient care, slightly less than one-third are specialists in primary care. Primary care physicians consist of family physicians and general practitioners, general internists, general pediatricians, and geriatricians. Of the nearly 956 million visits that Americans made to office-based physicians in 2008, 51.3% were to primary care physicians.<sup>1</sup>

# Visits to office-based physicians, non-primary care vs. primary care and within primary care, 2008



According to the 2010 American Medical Association Physician Masterfile, there are slightly more than 246,000 primary care physicians in the United States. This number, however, overestimates the number of practicing physicians and needs to be adjusted because the AMA Physician Masterfile includes some retired physicians and others who have left the workforce and a substantial number of primary care trained physicians now practice in non-primary care settings, including as hospitalists and in emergency departments. After adjusting for these two factors, the number of practicing primary care physicians in the U.S. is estimated to be approximately 209,000.
