ProviderOne to Start Updating License Info

As of January 23, 2012, ProviderOne will automatically update professional, pharmacy, and hospital license information from an interface with the Washington State Department of Health (DOH) for all Washington State providers. The license information will be retrieved directly from the DOH on a daily basis and will update license information in ProviderOne.

Shortly after the license update process begins in ProviderOne, claims will begin to be denied for expired licenses. Washington State providers who experience claim denials as a result of this new process will need to contact the Washington State Department of Health to address the status of their license.

Out-of-state providers will need to maintain their own professional, pharmacy, and hospital license information in ProviderOne.

Medical Marijuana

From WA DOH

The Department of Health recently received several reports and complaints about health care providers inappropriately recommending medical cannabis or not following the requirements established in law. In an effort to ensure that all health care providers are familiar with the law and follow requirements and practice standards when recommending medical cannabis, we have developed a list of frequently asked questions focused on providers.

Conditions and criteria for providing a recommendation are clearly established in chapter 69.51A RCW. It also includes a list of health care providers authorized to recommend medical cannabis. Before a provider recommends medical cannabis to a qualifying patient, a patient-provider relationship must be established, requirements and restrictions established in RCW 69.51A.030 must be met, and practice standards must be followed as with any type of treatment. Recommendations must include the information required by the law, must be written on tamper-proof paper, and must be signed by the provider.

State law establishes immunity against prosecution for authorized health care providers appropriately recommending the use of medical cannabis to qualifying patients. A provider may be charged with unprofessional conduct for not complying with the requirements and restrictions established in the law or for not following practice standards. It is important that providers understand that immunity is not extended to federal prosecution. Marijuana is not legal under federal law for any reason.

The DOH does not promote or discourage the use of medical cannabis recommendations yet wants to ensure that providers are informed about the law and exercise sound professional judgment when making these recommendations. Prescription Drug Monitoring Info Available

New system aims to cut prescription abuse and improve patient safety.

The Washington State Prescription Monitoring Program has collected more than 3.1 million records for controlled substance prescriptions across the state. And now prescribers have access to this information.

Last month practitioners and pharmacists started creating accounts to track patient prescription information. Since then, the most dispensed drug was Hydrocodone/Acetaminophen, the generic form of Vicodin. It accounts for more than 800,000 prescriptions and represents more than 44 million pills.

Practitioners can register for an account online (www.wapmp.org). Once registration is approved they can request and review patient information. Prescribers and pharmacists can use this data to intervene with patients earlier. They can also identify dangerous drug interactions, watch for misuse, and recognize under-managed pain or the need for substance abuse treatment.

The Department of Health already provides access to this system to our agency's health professional licensing investigators, the Health Care Authority, the Department of Labor & Industries, and the Department of Corrections.

Guidance for Pharmacists Regarding the New Chronic Non-cancer Pain Management Rules.

The 2010 legislature passed House Bill 2876 requiring that the medical quality assurance commission, and four other prescribing boards and commissions, adopt rules for the management of chronic non cancer pain. The board of pharmacy was not included in the requirement to develop rules.

The goal of the prescribing rules is to provide direction for practitioners who treat patients with chronic non cancer pain. Pain management is a dynamic and challenging area of medical care that often includes opioids.

An increase in overdose deaths and hospitalizations in Washington State due to prescription opioids parallels an increase in prescribing of opioids.

All prescribers of long-acting opioids are encouraged to have at least four hours of continuing education on that topic.

Practitioners who have 12 continuing education credits on the topic of chronic pain management within the prior two years are exempt from the requirement for a pain management consultation when prescribing more than 120 mg morphine equivalents per day

- ☐ Pharmacists are not required or expected to enforce these rules.
- ☐ Pharmacists are required to provide safe patient care
- ☐ If a pharmacist receives a prescription for 120mg or greater morphine equivalent per day, the prescriber can be contacted for clarification.

The Medicaid program of the Washington State Health Care Authority is implementing a policy that requires the Agency to determine the medical necessity of using the Emergency Room to provide health care services. This utilization review program will focus on the medical necessity of the place of service, not the medical necessity of the services provided. An effective date will be announced later.

2012 Legislative and Regulatory Agenda

Priority Issue: Authorizing Pharmacists to Accept All Prescriptions from Out-of-State ARNPs

A law passed in 2010 authorized pharmacists to accept prescriptions from ARNPs licensed in any state or in a province of Canada that shares a common border with the state of Washington. Shortly after the law was signed, a legal analysis identified a technical error. Only the pharmacy act was amended. For pharmacists to accept all prescriptions, a section of the state's controlled substances act also needed to be amended. This technical error resulted from an inadvertent omission when the bill was drafted.

House Bill (HB) 1486 would authorize Washington pharmacists to fill prescriptions for controlled substances prescribed by out-of-state ARNPs by amending RCW 69.50.101.

Status: Passed by the House of Representatives 1/17/12 and was referred to the Senate Health and Long Term Care Committee

Actively Support

SB 6037 Limiting access to reports and records of autopsies and postmortems

Status: This bill was amended to allow ARNPs, upon request, to meet with the family of a decedent to discuss the findings of the autopsy or postmortem. The bill is in Senate Rules.

HB 2186 Concerning licensed midwives ability to work with RNs and LPNs

Status: The bill passed the House of Representatives 1/26/12 and was referred to the Senate Health and Long Term Care Committee.

HB 2648 Removing the expiration for the additional surcharge imposed on registered nurses and licensed practical nurses to fund the Washington Center for Nursing

Status: The bill is in the House of Representatives Rules Committee.

Active Opposition

SB 6394 Requiring transparency for patients regarding training and qualifications of health care professionals

This bill would have required a health care professional that holds a doctorate degree to identify the type of license, registration, or certification they hold in all advertisements containing their name. Promoted by the Washington State Medical Association, the bill was unnecessary because the Uniform Disciplinary Act already precludes false advertising.

Status: Our lobbyist successfully worked with others to have the bill removed from a scheduled hearing and the bill died in committee.

HB 2366 Requiring certain health professionals to complete education in suicide assessment, treatment, and management

The bill now applies to ALL ARNPs, RNs and LPNs, not just psychiatric ARNPs and mandates 6 hours of suicide prevention continuing education every 6 years. AUWS opposes this mandate as ARNPs conduct a self-assessment of continuing competency needs and can obtain suicide prevention education if it is relevant to their practice and professional needs.

Status: It passed the House of Representatives February 10, 2012 with 92 yea 5 nay and is now in the Senate.
