### Health Care Authority Resets Changes in Interpreter Program

The Washington State Health Care authority says implementation of improvements in its medical interpreter program will be phased in during early September, with a new statewide contractor handling all interpreter assignments beginning Monday, September 24.

The new contractor – CTS Language Link of Vancouver -- will be active beginning September 10 for interpreter requests for September 24 or later. The program's current regional interpreter brokers will continue accepting appointments for interpreters through September 23. Thereafter, CTS will be the single statewide contractor for interpreter services.

Walter Neal, HCA Interpreter Services Program Manager, said the two-week overlap was planned in order to give providers and the new contractor time to phase in new procedures and let providers get oriented to the new system, which involves web-based reservation requests.

"This timetable lets providers continue to telephone and fax the regional brokers to request interpreter services for any appointments that will occur up to September 23," Neal said. "At the same time, our providers will have a few weeks to adapt to the new electronic, webbased system that CTS Language Link will be introducing."

Under the new system, all HCA contracted-provider requests will be handled electronically through CTS' secured web portal. The HCA contracted providers need to register with CTS and obtain a secure username and password in order to access the portal. Providers also must complete a signup form at CTS' website at http://hca.ctslanguagelink.com/signup/ "This will be a more efficient system and one that should improve service for both providers and the interpreters who will be assigned to these appointments," Neal said.

The new system was mandated by the Legislature in the Health Care Authority budget in hopes of cutting the state's cost of interpreter services by about a third. The state currently spends about \$29 million a biennium on medical interpreters.

In response, the agency developed a contract requiring the successful bidder to utilize web-based/online technology for processing, scheduling, assigning and managing requests for interpreters for all types of interpreting modalities: in-person, over the phone and video remote interpreting. Providers will be given authority to decide the level of interpreter presence required for specific interviews.

The interpreter system will also be used by Health Care Authority's sister agency, the Department of Social and Health Services, in arranging interpreter services for DSHS clients who are Limited English Proficient. HCA estimates that part of DSHS interpreter services will make up about 10 percent of the total interpreter jobs arranged by CTS.

# L&I Public Hearing

SSB 5801 directs the Department of Labor & Industries (L&I) to establish a statewide health care provider network to treat injured workers and to expand the Centers for Occupational Health and Education (COHEs) in the workers' compensation system. L&I is promulgating necessary rules in phases.

This third rulemaking phase is necessary to address existing department rules that may conflict with the network implementation. Changes to the following WACs are proposed for consistency or clarification: WAC 296-20-01010, WAC 296-20-01020, WAC 296-20-02705, and WAC 296-20-03015.

The public may comment on these rules by attending a public hearing or by submitting written comments. The hearing is scheduled for September 28, 2012, at 3:00, Room S117 at the L&I Tumwater building.

SSB 5801 mandated the establishment of a workgroup of medical providers from the Industrial Insurance Medical Advisory Committee and the Industrial Insurance Chiropractic Advisory Committee and business and labor representatives – the Provider Network Advisory Group (PNAG). L&I has been working closely with this group on the content of these rules. # New Name for Our State Immunization Registry

#### The Child Profile Immunization Registry has been renamed the *Washington State Immunization Information System*.

This change reflects the lifetime nature of the system because individuals of all ages in Washington State benefit from the Immunization Information System. This name change will not alter our services. The Immunization Information System will continue to work with our health promotion system – still using the name Child Profile – to serve the state's healthcare system and users in the most comprehensive ways possible. The Child Profile Health Promotion System distributes health and safety mailings to Washington parents of young children aged birth to six years.

The Immunization Information System does more than track immunizations. Users across the state can use it for vaccine ordering, emergency preparedness activities, and to access records for Washington residents of all ages. We hope that this new name will promote the use of the system for teen and adult immunizations too.

The system provides you and your organization with many tools, including:

- $\blacksquare \ \cdot A$  free, user-friendly way to keep track of immunizations.
- $\blacksquare \cdot \mathbf{A}$  statewide, web-based lifetime immunization registry.
- $\blacksquare$  ·Lists of immunizations that patients need.
- □ Immunization records access (especially helpful for child care, school and camp).
- $\blacksquare$  ·One place for immunization records, even when someone changes providers.

# Updated Recommendations for Tdap Vaccine in Adults Aged 65 Years and Older

Since 2005, the Advisory Committee on Immunization Practices (ACIP) has recommended a tetanus toxoid, reduced diphtheria toxoid, and acellular pertussis (Tdap) vaccine booster dose for all adolescents aged 11 through 18 years (preferred at 11 through 12 years) and for those adults aged 19 through 64 years who have not yet received a dose. In October 2010, despite the lack of an approved Tdap vaccine for adults aged 65 years and older, ACIP recommended that unvaccinated adults aged 65 years and older be vaccinated with Tdap if in close contact with an infant, and that other adults aged 65 years and older may receive Tdap. In July 2011, the Food and Drug Administration (FDA) approved expanding the age indication for Boostrix (GlaxoSmithKline Biologicals, Rixensart, Belgium) to aged 65 years and older. In February 2012, ACIP recommended Tdap for all adults aged 65 years and older. This recommendation supersedes previous Tdap recommendations regarding adults aged 65 years and older.


