#### **Washington Health Professional Services**

The issue of alcohol and drug use in the health profession continues to deserve attention. Research indicates that the health professions misuse drugs and alcohol at about the same rate as the general population (10-15 percent). Conservatively this means that 10,000 nurses in Washington State have struggled with substance misuse. The American Nurses Association estimates that six to eight percent of nurses use alcohol or drugs to the extent that is sufficient to impair professional practice.

As far back as 1988 the legislature recognized that existing law did not provide for a program of rehabilitation of health professionals whose competency was impaired. In response the Uniform Disciplinary Act (RCW 18.130) was amended to:

- □ Direct disciplinary authorities to seek ways to identify and support the rehabilitation of impaired health professionals.
- Allow health professionals to be treated so they can return to or continue to practice their profession in a way that safeguards the public.
- Establish an alternative to the traditional administrative disciplinary process.

The Washington Health Professional Services (WHPS) program provides an alternative to discipline path to the nursing and over 70 other health professions in Washington State. At this time WHPS is actively monitoring over 500 health professionals throughout the state who are under contract with WHPS and are actively involved in recovery.

Health professionals come to WHPS in several ways. First is by self-referral, health professionals who enter WHPS in this manner are not made known to their licensing authority. However, health professionals most commonly come to WHPS after a complaint has been filed against their license. In many cases these professionals are provided with an opportunity to enter

WHPS and avoid license discipline. This is the hallmark of an alternative to discipline monitoring program.

WHPS provides the following services:

- ☐ Case development: including initial assessment and intake, treatment referrals, and development of a return to practice and participation contract
- **Monitoring**: including coordination with employers, participation in professional peer support groups, and random drug screening.
- ☐ Outreach and education: including participation in conferences, consultation to institutions, and professional organizations and practice groups. Contact WHPS to schedule a presentation.

Advanced Registered Nurse Practitioners may be at risk for substance misuse due to factors such as access to controlled substances, variable schedules, work overload, and practice autonomy. As with all chronic progressive diseases early recognition and intervention yield the most effective outcomes.

#### Update to DOL Change of Gender Designation Request Policy and Procedures

The Department of Licensing (DOL) has updated the Change of Gender Designation policy effective June 3, 2013. The health care providers able to complete the Physicians portion of the Change of Gender Designation Request form have been expanded. The following professions have been added for Washington State licensed health care providers as it relates to gender designation change:

- ☐ Naturopathic Physicians (ND)
- ☐ Advanced Registered Nurse Practitioners (ARNP)
- ☐ Physician Assistants (PA)
- ☐ Certified Osteopathic Physician Assistants (OA)

The documentation needed to complete a request for change of gender designation has not changed for a Washington driver license, instruction permit, identification card, enhanced drivers license, or enhanced identification card. #### Tips 2013: "Talk With Your Doctor" Initiative State Tobacco Control Program Frequently Asked Questions (FAQ)

Q: What is the "Talk With Your Doctor" initiative?

A: As part of the Center for Disease Control and Prevention (CDC) National Tobacco Education Campaign (*Tips* From Former Smokers), CDC has partnered with national physician organizations and other state and national partners on a "Talk With Your Doctor" initiative. This initial effort seeks to: (1) engage health care providers in the *Tips* media campaign, (2) encourage health care providers to use the campaign to open up a dialogue with patients about smoking and quitting, and (3) empower patients to address the issue with their doctor.

CDC will highlight the "Talk With Your Doctor" effort mid-way through the *Tips* campaign. The week of May 27th through June 2<sup>nd</sup>, the *Tips* national television ads will feature the tagline: "You Can Quit. Talk with Your Doctor for Help." The "Talk With Your Doctor" call to action will continue through outreach and other media

activities for the remainder of the campaign. Activities that your program plans around the "Talk With Your Doctor" initiative should be timed to launch on or after the May 22nd embargo date.

Q: Why is CDC focusing on "doctors" for this initiative?

A: CDC recognizes that many health care providers play a critical role in helping tobacco users to quit — from pharmacists, to physician assistants, to dental hygienists, to nurses and nurse practitioners. The term "doctor" is used on the ads because formative research conducted at CDC suggested this term was universally understood by consumers to mean any health care provider. Terms like "health care provider" and "health professional" may be unclear to tobacco users.

Q: Who is participating in the initiative?

A: CDC is working with five national physician associations (American Medical Association, American Academy of Family Physicians, American Academy of Pediatrics, American College of Physicians, and American Congress of Obstetricians and Gynecologists) that have a long history of collaborating to increase tobacco cessation in health care settings. These groups are giving significant in-kind support to the initiative. As a state or local affiliate, you have a unique opportunity to leverage this initiative to prepare physicians in your state to better address tobacco use with patients.

CDC is also working to promote the larger *Tips* campaign through national partners and associations who work with nurses, pharmacists, dentists and hygienists. As national networks, state health departments and tobacco control programs, you are encouraged to promote the "Talk With Your Doctor" initiative through existing state and community partners.

Q: What materials will be produced for this initiative and where can I access them?

A: A specific section of the CDC *Tips* website will house all major materials that are being created for health care providers. Materials will NOT be printed by CDC, but will be available in printable/downloadable files on the *Tips* website at www.cdc.gov/tips. Please note that materials will be "phased in" on the health care provider tab of the website, coinciding with the national launch of the "Talk With Your Doctor" initiative. Materials include:

Q: What is the state health department role in the "Talk With Your Doctor" initiative?

A: State health departments are encouraged to leverage the national Tips media campaign to actively engage all types of health care providers and to encourage them to implement the evidence-based brief tobacco interventions like the 5As or the 2A&R. The "Talk With Your Doctor" initiative provides a unique opportunity for you to: (1) partner with state physician or health care provider groups to jointly promote the initiative, (2) solicit earned media to coincide with the national press event on May  $22^{\rm nd}$ , and (3) highlight ongoing or upcoming cessation efforts or health systems change projects in your state.

Q: How should state Tobacco Control Programs approach physicians and physician groups about the "Talk With Your Doctor" initiative?

A: The 5 Provider Organizations will provide CDC OSH with specific instructions for how to connect with their state affiliates. CDC will forward that information on to the state and territory tobacco control programs. The information can also be obtained from your PSB project officer.

Q: When should we approach physicians and physician groups about the "Talk With Your Doctor" initiative?

A: While general *Tips*-related outreach to health care providers can occur throughout the campaign, please coordinate "Talk With Your Doctor" focused activities with your PSB Project Officer to ensure that they synchronize with the larger national launch of the TWYD initiative. Leadership at state affiliates from AMA, AAFP, AAP and ACOG have been notified about "Talk With Your Doctor" so you can work in advance of the launch to plan activities with them to coincide with or follow the May 22 press event. As a reminder, public distribution of the "Talk With Your Doctor" materials is embargoed until after the launch on May 22.

On September 20-22, 2013 The Susan G. Koman Breast Cancer 3 Day is coming to the streets of Seattle (exact locations still to be announced) and the Medical Crew is looking for volunteers for a few hours (or a few days) to help make the event successful. All you need is a positive attitude, compassionate heart and an RN or ARNP license to participate. All training to be a team member will be provided prior to the event and most of the training can be done online. RN's who participate in all 3 days of the event can earn 27 CEU's. Medical crews are stationed every 3-4 miles along the 20 mile route each day to assist walkers along their journey as well as a larger facility at camp. Last year over 1200 bold walkers walked 60 miles raising over 4.2 million dollars; 75 percent of which directly go to fund breast cancer research projects (many of which are conducted here in the Seattle area) and 25 percent are used for local screening and outreach programs for the Puget Sound affiliate. This is an uplifting, inspirational event with many healthcare providers from around the state coming together to make a difference in the lives of walkers and those struck by breast cancer. EPHT is the ongoing collection, integration, analysis, interpretation, and dissemination of data on environmental hazards, exposures to those hazards, and health effects that may be related to the exposures. The goal of tracking is to provide information that can be used to plan, apply, and evaluate actions to prevent and control environ-

mentally related diseases. CDC is currently leading the initiative to build a National EPHT Network, to integrate these three types of data into a standardized electronic network.


### Launch of the National Nurse Practitioner Directory


Currently the site is in Beta testing and all NPs are invited to give it a try. Those who have previously been listed in the directory NPClinics.com are in the process of being moved over.
