Getting to know HEAL-WA

Staying abreast of the best evidence and evaluating information to support patient care can be challenging. Fortunately, RNs and advanced practice clinicians in Washington State have access to an online library of evidence-based information through the HEAL-WA web portal, http://healwa.org.

Authorized by the Washington State Legislature in 2007, and live (and available to RNs and ARNPs) since January 2009, HEAL-WA contains a wealth of information to support the best evidence-based patient care, including several dozen professional databases, nearly 200 ebooks, and more than 5,000 full-text journals. Point-of-care resources such as DynaMed and Nursing Reference Center provide access to evidence in support of patient care. The Natural Standard database offers evidence-based assessments of complementary and alternative therapies and modalities. HEAL-WA also gives you access to the Cochrane Library, widely regarded as the gold standard of evidence. VisualDx allows you to use a differential builder to confirm a diagnosis using images of various conditions. Bibliographic databases such as MEDLINE Complete and CINAHL Complete let you retrieve article references, including

abstracts in most cases, on topics of interest. References to specific articles in most of the databases are linked directly to the full text article if the journal is one that HEAL-WA provides access to. You can always search directly in the e-journals list for a journal article for which you already know the reference. Mental health information and patient education information are also available.

To see a list of what HEAL-WA has to offer, click on any of the links in the blue bar that appears across every page within the HEAL-WA site. Databases, ebooks, and full-text journals are all browsable from any HEAL-WA page. You can find additional information about how to navigate the web portal, and which databases will best answer most kinds of questions, on the "Where to Look" page at http://heal-wa.org/resources/where-to-start

Another resource that will give you an overview of what HEAL-WA contains and how it use it is a webinar that was given in February 2012. Oregon's Road to Reimbursement Equality

In 2009 one of Oregon's largest insurers decreased reimbursement rates for mental health services rendered by non-physician providers. Other insurers quickly followed suit. The resulting impact was to reduce providers' ability to maintain their practices and serve the mental health needs of Oregonians.

The Oregon state NP organization submitted their first version of state legislation, requesting parity reimbursement in 2011. That bill targeted mental health services, including a variety of disciplines; MSWs, psychologists and NPs. The bill proved to be too cumbersome, with different services being billed by different types of providers without assurance the same service was provided. This bill did not make it out of committee.

In 2012 a broader bill was introduced, addressing equal pay for equal work. The short legislative session that year curtailed discussion when disagreement arose regarding coverage for Primary care and mental health NPs as opposed to specialty services.

Hard work and broad collaboration during the 2013 presession achieved final, successful legislation. Physician Assistants are included in this lawmaking, as necessary allies, having achieved recent legislative successes. The primary argument focused on access to care; insurance policy decisions risked closing businesses, or providers dropping contracts that reduced reimbursement. Small business bureaus supported the legislation in rural areas where businesses were threatened while equal pay arguments resonated in more urban areas. With the support of labor unions, the AARP, and RNs statewide, Oregon legislators were convinced our work needs to be valued equally to other providers.

Lessons for Washington:

Know our friends and allies. We need to cautiously collaborate with partners we may not be familiar with. Many physicians support us, but the Medical Association may not. Medical Associations need a guarantee that equal reimbursement for us will not potentially reduce their income. Congressional Representatives from rural areas, typically thought of as more politically conservative, may support us due to their concerns about small businesses and the impact on local employment. More liberal representatives respond better to persuasion for equal pay for equal work.

To forward this resolve in Washington, we will need help across the state and across disciplines. – PAs can help, but in Washington have different practice guidelines.

Unions that pay for insurance plans want confirmation that their workers can see the promised health care provider and equal pay arguments resonate well with them.

Need bipartisan support.

In our state legislative resistance has focused on the differences on the duration and cost of education. However, we know that with public subsidies for medical school education the gap in costs between ARNP and MD academic programs is not great. However we are encouraged to focus the service provided, that we provide the same care, bill for the same services and have equal or better outcomes than providers with other academic backgrounds.

Work to do: meet with your legislators, make sure they know who you are, what is an NP.

Arguing for gender bias or comparing academic backgrounds leads to controversy and confusion. Points that are inarguably strong include:

Assuring access to primary care for patients in all communities. A sufficient workforce will prevent unnecessary ER visits, improve health outcomes and reduce costs.

Providing fair choices of providers to all patients

Sustaining small businesses

Equal pay for equal work

Supporting for individual business owner struggling against large corporate interests

Assuring a sufficient workforce under the Medicaid expansion and for the aging population entering Medicare rolls

The goal of tracking is to provide information that can be used to plan, apply, and evaluate actions to prevent and control environmentally related diseases. CDC is currently leading the initiative to build a National EPHT Network, to integrate these three types of data into a standardized electronic network.


Launch of the National Nurse Practitioner Directory
